10:45 a.m. IV. Senate and Assembly Bill Tracking - Best Practices

According to available real-time online legislative tracking services, more than 5,100 bills were introduced by the California legislature in the 2021-2022 regular session and more than 2,300 bills were signed into law. While most bills have minimal relevance to county Public Works departments, local agencies must monitor legislative activity and – when necessary – deploy considerable resources to support or oppose bills that can fundamentally impact core operations.
