CEAC Needs Your Help!

As the CEAC President for 2018, I chair CEAC's Oversight Policy Committee (OPC) and want to share some developing news.

In December 2017, the OPC was reorganized. The newer, focused OPC now consists of the President, Vice President, Secretary, Immediate Past President, Parliamentarian, and the CSAC staff member to CEAC (ex-officio).

Why reorganize? In gathering input, it became clear that it was the best way to accomplish two ambitious goals: increase active participation in CEAC and to evolve CEAC's outreach and messaging. The importance? Clearly, a unified and trusted

voice on all things Public Works is desired. CEAC members, legislators, affiliates, and the general public should have confidence in CEAC's professionalism, position, and message – whether it is on the importance of Public Works in any community, pending legislation, or regulatory challenges and policies.

Since December, OPC has been meeting bi-weekly, developing a 2018 work plan and making practical changes to ongoing CEAC operations. The most immediate operational change involves evolving charters for each of the CEAC Policy Committees. These charters come directly from the CEAC Officer's Manual and have Parliamentarian approval. They clearly define expectations for those who would be the chairs and vice chairs and include provisions for additional e-meetings and webinars. The charters align Policy Committee activities with the CEAC mission/vision - more on this to come.

The OPC knows that to increase active participation, CEAC must demonstrate its relevance to membership. To do this, **CEAC NEEDS YOUR HELP!** CEAC needs to know what's important to you. Please gather your thoughts on the matter. We will be sending out a survey within the next few weeks.

How can you help? By engaging in one or more of the Policy Committees. Just let the committee chairs know of any subjects that are important to you so that they can be placed on an appropriate agenda. Note: Committee Chair contact info is on CEAC's website.

Another way to help is to participate in your Regional Meetings. We will be discussing issues of regional import. I believe that you will benefit from the discussion, interchange, and dissemination of Public Works information that occurs.

San Luis Obispo County

After months of vetting qualified candidates, the County has hired its next Public Works Director, a key member of the County's leadership team. **Colt Esenwein** replaces

Wade Horton who was appointed to the position of Chief Administrative Officer by the Board of Supervisors in November 2017.

"**Colt Esenwein** has a reputation as an innovator who takes action to make projects work," said John Allan Peschong, the Board of Supervisors Chair and District 1 Supervisor." Colt understands the need to build coalitions of support and balance competing interests. I'm confident he is a leader who will get the job done and I welcome him to San Luis Obispo County."

A registered professional civil engineer with the State of California, Colt brings more










Member Spotlight

GUY CHARLES KULSTAD

February 23, 1930 - December 14, 2017

Guy Charles Kulstad was born February 28, 1930 in Bend, Oregon and passed away peacefully December 14, 2017 at his home surrounded by family. His grand-parents Charles and Anna Boyd were founding pioneers homesteading in Bend.

After Guy graduated from Bend High School, he set his sights on becoming a civil engineer. He pursued that goal starting at Los Angeles City College. He then was accepted to UC Berkeley and graduated with a Bachelor of Science degree in Civil



Engineering in 1958. His education was interrupted when he was drafted into the Army during the Korean War where he served in the Army Corps of Engineers as a combat engineer, surveyor, construction foreman and achieved the rank of Sergeant.

After his discharge, Guy married his wife, Bonnie, and completed his education. His career in civil engineering began with the Los Angeles County Road Department in 1951; then as Director of Public Works for the City of Benicia, CA; followed by Deputy Director of Public Works for Solano County. His final career move was Director of Public Works, Road Commissioner, County Surveyor, and Flood Control Engineer for Humboldt County from December 1, 1965 to July 18, 1992.

Accepting this position with Humboldt County after the catastrophic 1964 flood was a monumental challenge for a young man not yet 35. Called "the Kid" by the old guard when he started, he later earned the moniker "Chief" and at other times that "SOB". He loved the work and found his 28-year career with Humboldt rewarding and stimulating. Guy devoted the rest of his life to the people and places that make Humboldt County such an amazing place to call home.

Guy was a licensed Civil Engineer in California, Oregon, and Washington. He was a licensed Traffic Engineer in California, a licensed Land Surveyor in Oregon and held a California Community College Credential. Guy was a fellow in the American Society of Civil Engineers. And a member of both the National Society of Professional Engineers and the County Engineers Association of California.

Guy attempted to live by the precepts of Bessie J Stanley's poem: "SUCCESS"

"He has achieved success who has lived well, laughed often, and loved much; who has enjoyed the trust of pure women, the respect of intelligent men and the love of little children; who has filled his niche and accomplished his task; who has left the world better than he found it whether by an improved poppy, a perfect poem or a rescued soul; who has never lacked appreciation of Earth's beauty or failed to express it; who has always looked for the best in others and given them the best he had; whose life was an inspiration; whose memory a benediction."

Do you recall seeing the picture of CEAC President **Jeff Pratt** in the December Newsletter wearing the infamous CEAC hard hat? Sound familiar? That was the opening line, with Jeff substituted for Maurice Shiu, in the Spring 2006 Newsletter.

FROM THE SPRING 2006 NEWSLETTER

Do you recall seeing the picture of CEAC President **Maurice Shiu** in the last Newsletter wearing the infamous CEAC hard hat? As you can see in the picture, or "up close and personal" if you've attended a CEAC installation ceremony, the hat is adorned with a "bunch of stuff". I'm hoping that identifying the "stuff" will not only be interesting but will provide more information concerning our past.

As you may know, **Bill McIntosh** is the oldest living Past President and therefore I questioned Bill about the hat's origin. Although probably not the first recipient, Bill feels that he was "one of the first" when he became our President in 1963. Then, in 1964, Bill presented the hat adorned with a Lassen County A-1 route marker decal to his successor, **Dave Pierson**, Imperial County.

It is my belief that the additions made to the hat in the early years were to make it functional, e.g. running lights, horn, beer dispenser, etc. It would appear that later on the additions reflected something which occurred during a term in office. For example, the guy jumping rope atop the hat was added by **Art Goulet**, Ventura County, 1988-89 CEAC President. Those attending CEAC Board meetings at the Lake Almanor bedroll conference will recall Art "jumping up a storm" in the Camp Conery parking lot. The can of Snappy Tom was added by **Mike Walford**, Contra Costa County, 1990-91 CEAC President. Seems as though Mike, as our fearless leader, was forced to use a substitute mix at the Snappy Tom Reception during the 1991 NACE Annual Conference in Cincinnati. The train was added by **Max Bridges**, San Benito County, 1997-98 CEAC President, to signify his "jumping ship" to run the North Coast Railroad. Most recently, Immediate Past President **Tim Hackworth** added a small measuring tape on which he place the Placer County logo. The tape apparently has no significance but merely a place to affix the logo. In addition, Tim added a California quarter with condor, dime, nickel, and penny (change) to signify the changes taking place in county gov't and our Association.

I thought it would be interesting to try to identify as much "stuff" as possible and learn why it was added. Therefore, I'd like to hear from all of you who placed something on the hat or if you recall someone else's addition. John joined Santa Cruz County in 1991. In 2009, he was appointed Director of the Department of Public Works replacing the man who hired him, Tom Bolich.

Presleigh guided the County through recovery from multiple natural disasters. During the winter of 2016-17, storms caused more than \$122 million in roadway damage in the unincorporated areas alone – the most costly winter in County history.

To speed recovery, Presleigh fast-tracked a number of projects, brought in storm recovery experts and hired outside consultants to process as many repair projects in the shortest possible time frame. The Department's work was recognized by the U.S. House of Representatives, California Legislature and Board of Supervisors, and John was honored with a 2017 "Community Hero" award by the Aptos Chamber of Commerce.

"I'm particularly proud of all that John's accomplished, especially his key role with CEAC. Thanks to John's tireless efforts in working with our State representatives, and lobbying on behalf of the citizens and motorists of our County, there is finally hope that our local roads will receive the attention they deserve," Bolich said. "I know the County of Santa Cruz will continue to benefit from John's legacy."

KINGS COUNTY - would like to brag a little about their entry in the 2018 Outstanding Local Streets and Awards Project Awards program. Kings County was first loser (but, Finalist sounds much better) in the Complete

Streets Projects category, losing to the City and County of San Francisco but beating the City of Beverly Hills - big doings for little Kettleman City!





KETTLEMAN CITY SAFE ROUTES to SCHOOL and ROADWAY RECONSTRUCTION PROJECT - Extensive public outreach during development of the Kings County 2035 General Plan revealed concerns of excessive speeds along State Route 41 and the need for children to have a safe route to school. In 2009, Kings County received a Caltrans Transportation Planning Grant and an Environmental Justice Grant. Recommendations from the Kettleman City Safety and Community studies and workshops were used as the basis for the Federal Safe Routes to School project. The project included new pedestrian pathways, ADA compliant ramps and widened roadways reconstructed utilizing the full depth reclamation with cement treatment method. This approach reduced material cost and construction and the project's overall carbon footprint, and created a shared area for bikes and on-street parking.





TULARE COUNTY — Constructed a 4-acre community park in Earlimart. This-one-of-a-kind park includes a children's play area, open turf area, sporting fields and ball courts, picnic facilities, a multi-use event area, lighted walking paths, and community art. The park opened at the beginning of the year. It will serve as a community center for the community as well as a location for sports events and public gatherings. This project was developed through a collaboration with California Natural Resources Agency and California State Parks, the Earlimart School District, as well as Tulare County and the Tulare County Flood Control District.

This project includes flood control measures such as a regional stormwater retention pond and urban groundwater recharge facilities. The park's stormwater management facilities have been designed using modern sustainable development techniques and practices such as biofiltration systems, stabilized decomposed granite pathways, and gabion seat walls which act as permeable floodwater routing devices. The basin will utilize current sustainable and ecologically sensitive design features not commonly in use in rural Tulare County. Additionally, the project will provide educational and interpretive signage describing these "green" features.

MADERA COUNTY

The purpose of this roundabout project is to improve safety by making improvements to the existing intersection of Road 225 and Road 274 near North Fork. The project converts the existing nonstandard 4-leg, 3-way stop controlled intersection to a roundabout. The existing intersection configuration is extremely uncommon which makes it difficult for people to safely navigate.



MADERA/FRESNO COUNTIES

Italian Bar Road Bridge at San Joaquin River (Redinger Lake) Replacement Project:

The existing bridge straddles Madera and Fresno Counties. Fresno County owns and maintains the bridge, with Madera County maintaining the roadway approach on its side. This bridge was built in 1935 and was modified in 1951. It is approximately 241-ft.

long and 12-ft. wide and is fracture critical because of lack of redundancy of the two-girder approach spans and the pony truss main span with fracture critical or fatigue prone evidence on the floor beams, steel girders and welds resulting in the need for load restrictions being posted at both abutments.

Funding has been approved for Fresno County to replace the existing structure. Madera County is involved to ensure that their side improvements are completed per County standards and assist in the coordination of any work within right of way. No funding is being provided by Madera County. Fresno County has provided a budget for Madera County's time. Madera County also assisted Fresno County to obtain temporary construction easements for a staging area during construction adjacent to the existing bridge/culvert.

The proposed replacement bridge will be an approximate 203.5-ft. long and 25.5-ft. wide, (2) span composite concrete deck with Type 80 concrete barriers, on top of steel "I" girders, on top of a cast-in-place (CIP) RC pier cap with 84-in. diameter CIDH RC piles with 60-in. diameter CIP RC column extensions, and seat type abutments with spread footings anchored into rock on one end and on 30-in. CIDH RC piles on the other end. The project is expected to begin construction in 2018-19.

SAN JOAQUIN COUNTY

San Joaquin County will soon bid farewell to a familiar ferry and welcome a new two-lane concrete bridge across the banks of the Middle River near Stockton.

"It's been a long-time coming but the countdown has officially started for this awaited project that will drastically cut down the river crossing times and ferry in – so to speak– a more efficient mode of transportation across the Delta," said San Joaquin County Supervisor Chuck Winn.

The existing Woodward Island Ferry, which has plied the waters of the historic Delta since 1936, has long frustrated Delta farmers on both land and water as its submerged cable can prove hazardous to boaters, cars and drivers alike, as even farmers have fallen into the waters during rough weather.

The ferry will be replaced by a 675-foot-long bridge. The bridge alignment will allow the existing ferry to remain in operation during construction. The new structure is a seven-span bridge with a mechanically removable center span to allow unlimited vertical clearance when removed and 30 feet of vertical clearance when the span is in place. Construction is scheduled to begin on July 23, 2018.

Director of Public Works, is driving an excavator through the old County shops in a fit of rage. The shops were built in 1958 and have outlived their useful lives. The shop in particular was in sad shape, with a leaky roof, bad lighting and a workspace that was either too hot or too cold.

The new Administration building is approximately 19,000 SF. The new Shop Building is approximately 40,000 SF.

The entire project cost approximately \$15 million. Some of the features that are working really well are the permeable pavers. They have had two of parking lots take 1-inch storms and the system is percolating the runoff as designed. The estimated useful life of the permeable paver parking lot is at least 75 years. The shop has heated floors, venting to perform Compressed Natural Gas vehicle maintenance, tall ceilings, and large bays.

Giving Natives a Chance.

Bringing the Community into the Practice of Modern Flood Control

Contra Costa County's Flood Control District

has worked hard to develop environmentally sound approaches to its projects, and often brings the community into the picture whenever possible. On December, 2, 2017, the District sponsored its 5th annual "Giving Natives a Chance" event - lending a helping hand in restoring native grasses to an area in Central county.

This year's enthusiastic volunteers began the day with an hour dedicated to creek cleanup. They picked up more than 50 bags of garbage - approximately 1000 pounds of trash removed from the creek that would have entered the bay and ultimately the

Pacific Ocean. Next up was the process of weeding and digging, and then planting approx. 7000 native grass plugs. Mike Carlson, Deputy Public Works Director and Concord Vice Mayor Edi Birsan welcomed the volunteers and thanked them for their efforts. John Zentner of the Restoration Trust explained the importance of these plants in the ecosystem, the function that each species would perform in the channel, and then trained the volunteers on the proper planting technique

"Giving the Natives a Chance" started in 2013 on the west side of Solano Way in Concord. This year's event was the largest attended event to date with nearly 150 volunteers giving up their Saturday morning. Of this group, there were more than 100 high school students giving back to the environment and their community.

The District would like to thank all the volunteers for all of the support. This year the group included students from Alhambra High School, San Ramon Valley High School, Boy Scout Troop 239, Public Works employees, and many other community members who were generous enough to donate their time.

After 5 years of volunteer-powered restoration work, Contra Costa County has created significant habitat improvements and re-established native vegetation communities in the Clayton Drain flood plain. The County expects expect to have even greater success in years to come.
