

# **2022 CEAC Engineer of the Year**

It is my pleasure to nominate **Mr. Scott Deleon** as the 2022 CEAC Engineer of the Year. A little background about Scott:

Scott began his work with Lake County as an Engineering Technician while attending college. He continued working for Lake County and served as the County's Principal Engineer from 1987 until 1998. Scott returned to Lake County in 2010 as the County Water Resources Director. In 2012, he was appointed to the position of Public Works



Director and the position of County Water Resources Director was incorporated into that position.

He has served as the CEAC Regional Director from 2016-2018 and has served as the Scholarship Committee chair for more than 5 years.

I want to relate a story that demonstrates Scott's dedication to CEAC. Scott was the lead for the Bedroll Conference in 2019 and had materials for the conference stored at his home. There was a fire in the area, and not only was Scott unable to leave Lake County because of the emergency, but he was under mandatory evacuation from his home. Because of Scott's commitment, he arranged with the Sheriff for an escort to get into the evacuation area and to his home to load the materials for bedroll. Then, his wife, Melody delivered the materials to the Bedroll Conference. I have always, thought that is the kind of dedication that Scott deserves to be recognized as the CEAC County Engineer of the Year. I also have thought it is the kind of serve that should result in Melody receiving the Buddy Award.

I find it difficult to imagine anyone in CEAC who has not gone through the Chairs having more point for this award than Scott.

# 2022 CEAC Surveyor of the Year




**Raymond Mathe** was hired as the San Diego county Surveyor on January 8, 2016. Prior to that, he was the Senior Registrar Land Surveyor for the California Board for Professional Engineers, Land Surveyors and Geologists, a position he held from 2012 through September 2014. He also served as Chief Surveyor for the Coachella Valley Water District from October 2014 to April 2015. Previously, he was the County Surveyor for Orange County from 2004 to 2012. His experience includes six years project management in private practice and as the Deputy County Surveyor for Riverside County.

Since he was licensed in 1989, Ray has been active in the California Land Surveyors Association (CLSA) and the Western Federation of Professional Surveyors (WFPS) serving as local chapter and State CLSA President; Chairman WFPS; past Education Chairman; all facets of development of the State Land Surveyor exam; and an instructor in engineering and land surveying. Presently, he is the Western States Director for the National Association of County Surveyors (NACS).

Ray obtained a Bachelor of Science degree in Workforce Education and Development from Southern Illinois University of Carbondale in 1995 and an Associate Degree in Land Surveying from Riverside Community College in 1984.

As a member of CEAC, he has been closely involved in the two major edits of the Guide to the Preparation of Records of Survey and Corner Records (2004 and 2020). As County Surveyor, he has partnered with the private surveying community on many issues - the latest is the modification of an online research system that will be able to house and make available many historic private surveyor notes. Making these notes more accessible will benefit and reduce the cost of retracing historic property lines.

# **2022 CEAC Scholarship Awards**

# **CEAC Memorial Scholarship Program**

The CEAC Memorial Fund was initially established in 1972 with the purpose of aiding deserving engineering students in their quest for an engineering degree. More recently, the award has been broadened to include students pursuing degrees in surveying.

The inertia for the Fund was the untimely and tragic death of two of our CEAC members, Bill Jones of Solano County and Howard Van Veyper of Yolo County, who perished in a boating accident on their way home from the annual meeting that year in Monterey.

Money to support this worthwhile CEAC activity initially came from CEAC members who donated to the fund in remembrance of a family member or loved one.

CEAC will grant up to three \$2,000 cash scholarships to qualified engineering or land surveying students for study leading to a bachelor's degree in civil engineering or land surveying. Each student must be enrolled in upper division course work leading to a civil engineering or land surveying Degree, with a high grade point average, have demonstrated a need for the scholarship, and have participated in related outside activities such as a Student Chapter ASCE, Student Member CLSA or American Public Works Association. These various factors, including outside activities, will be considered in awarding the scholarship.



Happy Holidays to all. As we wrap up another year I will share a vision of how NACE plans to operate in the coming year and where they plan to focus their attention.

NACE Administration has modified it's staffing model. Those changes include – Connie Radoulovitch has retired, congratulations to him! Staci Morgan is now a part-time contract employee, she is focused on NACE conference management. NACE has hired a new full time communications staff person, her name is Emily White, Congratulations Emily – Welcome! Lastly, Kevan



Stone has hired a consultant team to manage all back office duties and corporate membership recruitment. All of this change has resulted in a projected budget savings of \$40,000 annually.

Continuing along the lines of budget, this past NACE budget year saw dramatic inflation increases in the cost of hosting conferences. To match this inflationary increase, conference dues will be increased. This increase is expected to be in the range of \$100.

The NACE Board took action this past fall to focus more attention on member participation in committees. NACE considers committee membership and participation and representatives to task forces or organization liaisons a critical part of our goals and objectives. Participation engages NACE members in the business of the association, supports the NACE strategic plan and enriches and rewards individual members professionally.

With this in mind, guidelines have been developed for these activities. The purpose of the Technical Committee will be to coordinate training and professional development at association events in conjunction with NACE Staff to ensure that members receive up-to-date technical information and new improvements in the public works industry. The Technical Committee shall be the clearinghouse for all technical training, research and coordination with affiliated organizations. The Technical Committee shall have several subcommittees that include, but are not limited to: Emergency Preparedness and Operations, Safety and Technology, Structures and Environmental, Unpaved Roads, Pavement Preservation. Standing committees are the permanent committees as defined in the NACE By-Laws. Standing committees typically deal with the operational issues of the association. **Editor's Note**: The following article appeared in the March 2010 Newsletter. It seems very appropriate considering CEAC President Brian Balbas' Message to all of us leading off this issue of the Newsletter.

### **Forty-Five Years of Progress?**

The following is a report that appeared in CEAC's January 1965 Newsletter prepared by Editor Bob Glenn of I.T.T.E. highlighting the activities, accomplishments and recommendations of the 1964 CEAC President, **Bill McIntosh**, of Lassen County:

Bill traveled over 15,000 miles during his year as CEAC President which required a total time of 31 days, attending 15 meetings including at least one meeting in each Region. He counts his trip to Washington, D.C. for the NACE meeting, together with V.P. Dave, as one of the bright spots in his regime and, in a measure, was a reward for time spent on behalf of CEAC. They attended a White House lawn party, met President Johnson and family, V.P. (elect) Humphrey, and six cabinet members.

Among other accomplishments listed for the past year was the development and issuance of CEAC membership certificates, including those for life members; action taken to rejoin the Legislative Council of Professional Engineers; and cooperative work with NMACE in the development of a Maintenance Manual.

In closing, President Bill offered the following:

"I would like to leave this office with a few recommendations for the future:

- 1. Continue active support and participation in the NACE Program.
- 2. Encourage Regional Associations to continue their good work and improve their effectiveness wherever possible.

- 3. Bring about closer relations between CEAC and its members through the Region of each CEAC Committee. In turn, each committee member and Regional Director should keep their group in touch with the activities of CEAC by reporting the results of committee and Director meetings at their Regional meetings. There should be no reason why the entire membership should not be fully and currently informed of the business of the County Engineers Association.
- 4. Continue and <u>protect</u> our close association with the Supervisors Association.
- 5. PLEASE HELP BOB GLENN GATHER INFORMATION FOR OUR NEWSLETTER!

In closing, I extend to my fellow officers, directors, committee chairs, committee members and friends my warmest gratitude for helping make this past year a propitious one."

As I (the Historian is now writing for myself) have now been retired from County public works processes for over seven years and may be somewhat out of touch with the day to day business of my own County (Siskiyou) as well as CEAC, I am still quite interested in helping to see that our CEAC organization continues to be a strong force in Statewide public works issues and endeavors.

When I ran across the copy of the 1965 CEAC Newsletter in my files and read the portion that pertained to President Bill McIntosh's report and recommendations upon concluding his term, I thought it would be interesting to reflect on the goals he presented and whether any of these goals are relevant today, forty-five years later.

The first of these goals, to actively support and participate in the NACE program seems to be alive and well particularly due to the influences and work of Phil Demery, NACE President 2010; Scott McGolpin, NACE President 2020; and the CEAC Representatives to the NACE Board of Directors starting with Phil until he was elected the NACE Western Region V.P. in 2006; George Johnson till 2011; Pat DeChellis until 2015 pending his upcoming retirement in early 2016; Scott until he was elected the NACE Secretary/Treasurer in 2018; Mike Penrose until 2019; and Matt Machado ever since. Each have taken the time to become involved in NACE committees, to get to know public works peers and issues in other states, and to provide professional representation at the national level for California.



The next two of Bill's recommendations deal with the work of regional associations and the dissemination of information through the regional associations and the various CEAC committees to the membership. It is my belief that work of may of the regional associations has suffered in recent years. Although there are a few regions that have regular meetings, many only meet sporadically and some not at all. The

regional associations are an important link in fostering ideas and information to be passed onto the CEAC Board and to the various committees as well as an important vehicle to transfer information

back to the local CEAC membership. The Board and the committees need to know what is important in your regions to appropriately develop a work program, legislation and policy.

The fourth recommendation to continue and protect CEAC's association with the Supervisors Association has changed dramatically over the years. Some of the reason for this is probably structural. In the distant past, the Road Commissioner was the "go to" guy for the County Supervisors when it came to getting things done on the roads or in the public works arena. Not so today. As County Organizations became larger, the CAO positions and their chain of command often became the go-to persons and the direct link to public works was often lessened.

Now, are these forty-five year old recommendations of Bill McIntosh still relevant today? All we have to do is look at the four goals that have been developed for CEAC Vision 2012 and this question is answered.

The four Vision 2012 goals are as follows:

- 1. CEAC will be recognized as a leader in advancing public policies as they relate to public works for the communities we serve and for the benefit of all Californians.
- 2. CEAC member will be informed of the programs and projects undertaken by CEAC, and actively involved in these programs and projects for their benefit and the benefit of CEAC.
- 3. CEAC will become an entity that the public, the elected officials and other government agencies know of and know want we stand for.
- 4. CEAC will influence and partner with regional/state/federal agencies.

Past President, Peter Rei, asked each of the Regional Directors to get involved by taking these goals and discussing them within their respective regions to help create a work plan that will enable the goals to be accomplished. Current President Pat DeChellis has made it a goal to attend at least one meeting of each of the regional associations during 2010. Both of these efforts are to reinforce and recreate the good work that can be achieved with the aide of the regional associations.

Although our roles in public works have expanded over the years and new legal, fiscal and environmental obligations have complicated our jobs, we still must strive to create strong working relation-ships at the local, regional, state and federal levels to strengthen our CEAC organization, just as was suggested forty-five years ago.

**Editor's follow-up note:** For those who haven't, please read the CEAC President Brian Balbas President's especially the 2nd page. Bill McIntosh's recommendations for CEAC after he completed his year at CEAC President (1965) and the Historian's follow-up 45 years later still resonate today.

### <u>YUBA COUNTY</u>

Big News! Yuba County was awarded a ~\$27million ATP project for our West Linda area for bike lanes, sidewalks, etc. We will be prepping for that transformative project!

### McGowan Parkway Bicycle Lane and Pedestrian Improvement Project

Project originated as an ATP project to install sidewalk and bike lanes. With additional help from LPP and Yuba Water Agency, the County is also installing a two way left turn lane, right turn pocket, drainage infrastructure, and a road rehabilitation between State Routes 70 and 65. Lastly, to support Olivehurst Public Utility District's (OPUD's) future south county annexation project, the County of Yuba is granting ~\$1.9million to OPUD and managing the construction of the sewer/water infrastructure along this roadway. This is mutually beneficial, as the County was able to meet our ATP timelines, OPUD doesn't have to construct their improvements in a new roadway, and the impact to the public is minimized.

Constructing \$5.8million of bike lanes, sidewalks, a bus turn out, traffic improvements, drainage improvements, road rehabilitation, and sewer/ water infrastructure.

Partnering with OPUD to install the first portion of their South County Annexation Project for water/sewer infrastructure

### North Beale Road Complete Streets Phase II

The current phase of the project (Phase 2) includes constructing complete street improvements between Hammonton-Smartsville Road and Linda Avenue. Over the last two funding cycles through the Sacramento Area Council of Governments (SACOG), Public Works was successful in amassing \$4,529,000 in federal aid funds toward the Phase 2 project. The additional funds to complete the ~\$8million project included development impact

fees, resource depletion tax, and Yuba Water Agency drainage funds. The work consisted of constructing bicycle lanes, curbs, gutters, sidewalks, driveway improvements, drainage facilities, streetlights, transit enhancements, median landscaping, and other streetscape features. The work will create a safer more usable roadway for pedestrians, bicyclists and motorists. Furthermore, it will provide a more aesthetically pleasing corridor to enhance economic development.

Project nearing completion with contractor completing punch list items

Project was \$7.9million of bike lanes, sidewalks, drainage facilities, streetlights, transit enhancements, median landscaping, and other streetscape features.

### **Iowa City Road Bridge Replacement**

Replacement of a structurally deficient bridge from 1934.

Project nearing completion and is planning to be paved week of Dec 5<sup>th.</sup>

Construction of single span, ~45', cast in place slab at \$2million.



### **Camptonville Emergency Storm Drain Project**

The County recently identified a failing storm drain. The storm drain, which was made of concrete, was installed approximately eighty (80) years ago and was failing at the joints. These joint failures were allowing water and soil to

enter the storm drain. This water entering the joints was causing public safety issues such as sink holes. Within 3 days, the County had plans/specs prepared and the project was out to bid. The project was just completed in time for winter storms.

Project was completed this fall.

Construction of 1200' of storm drain and 10 drainage inlets with a total construction cost of ~\$350k



County Road 40 Bridge over Cache Creek Replacement Project, located in the Cache Creek Regional Park Lower Site, Rumsey, CA. Project was completed in November 2022. Design engineer was MGE Engineering. Construction manager was Consor. The bridge replacement reestablishes CalFire's ability to cross the creek to access a wildfire prone area of Yolo County. The previous, failed, low water crossing bridge was closed in 2008.



General interest in resurrecting the Bedroll Conference, chasing some good leads for location, anticipate a revival in 2023. Machado/Leamon looking forward to dominating cornhole tournament again at this conference.

Matt Randall – **Sacramento/Mother Lode** – Note to CEAC Newsletter Editor that he is working on the Motherlode newsletter update. Plan on meeting more regularly in 2023, lots of competing meetings that distract from Regional Meeting.

David Leamon – **San Joaquin** – New President/Regional Director, Fritz Buchman, San Joaquin County, VP Dominic Tyburski from Kings County, Met in Fresno in October to finish the 7 meetings in 2022, all Counties but Mariposa. ### 7. Treasurer's Report: (Johnson)

CEAC is experiencing a budget shortfall, a sub-committee was assembled to evaluate funding alternatives. Three recommendations from the sub-committee:

- 1. One is to increase dues 10% per year for members and affiliates for three years.
- 2. Second recommendation is for job postings costs to increase from \$75 to \$125, Cities from \$150 to \$200.
- 3. Third recommendation to increase revenue is to raise the registration on the Fall Policy Conference from \$100 up to \$150. Combined proposals would increase revenue by \$30,000 per year.

The CSAC service contract has an annual CPI inflationary factor that is projected to increase expenditures by approximately 8%, raising the cost from \$219,286 in 2022 up to \$237,000 for 2023.

The good news is that additional counties have since paid their member dues, there are only two counties that have not yet paid their member dues for 2022: Sutter and Alpine. Matt Randall is working with two counties to get payment, and stated that Sutter will pay.

Including the revenue and expenditure increases into the 2023 budget is projected to provide CEAC General Fund Income of \$350,000 against projected expenditures of \$348,300, which creates a balanced budget.

George noted that the Board has made the right decisions to get the revenues aligned with the expenditures.

### **Attachment 2 - Action Item - Consider Subcommittee recommendations**

Increase member county and affiliate dues by 10% per year for three years.

Increase the charges for job posting for both member counties and partner cities by \$50, which will change member county posting costs from \$75 to \$125, and city partner costs from \$150 to \$200.

The registration cost for the annual policy conference should be increased from the current charge of \$100 to \$150.
