1	I hope you all had a great summer and are enjoying the Fall Season. Winter and the winter rains will soon be upon us. The 14 th Annual CEAC Policy Conference was held on August 28 and 29 in Sacramento. Topics discussed included the growing impact of homelessness on our operations, the collapse of the recycling market and the issue of handling and processing green waste and food waste, the FAST Act reauthorization, updates to legislative priorities, and the limited number of the licensed land surveyors in California.

4	The Land Surveyor shortage discussion was passionate at times and seems to be an issue that we all have opinions on but need to work collectively to find a solution. The issues
6	revolve around increasing the number of Land Surveyors (LS) but not compromising the technical and field experience necessary to practice as a LS. The main issues are the short-
8	age of colleges that offer Land Surveying curriculum, the amount of field work that should be required to qualify to sit for the LS exam, and allowing CEs to sit for the LS exam by
13	virtue of their registration as a CE. Bob Bronkall, Humboldt County, who is a Licensed Land Surveyor, Civil Engineer, and Traffic Engineer (wow!) has agreed to convene a group
14	of Land Surveyors and Civil Engineers to find areas of agreement for a path to increase the number of licensed Land Surveyors in California. It's a difficult problem to solve, but we
16	can all agree that we'd rather solve this problem collaboratively as professionals in the field rather than have a solution being thrust upon us through legislation. I'm confident
18	that a solution can be found.
19	The inaugural meeting of the Administrative Committee was held on the last day of the Policy Conference. We received an update from Orange County on progress made to clarify details of how Job Order Contracting (JOC) can be used by counties, as well as expanding its use for "new" construction and allowing multi-year contracts. Orange County will continue to provide CEAC with updates on progress and will work with CSAC staff on any proposed legislative efforts moving forward.

Much of the Admin Committee discussion centered around selecting topics for further discussion at the CSAC Annual Conference coming up in December in San Francisco. The Committee was presented with a list of 26 topics that Public Works and Transportation agencies are dealing with including the FEMA/FHWA Disaster Relief Process, Risk Management, Climate Action Plans, Impacts of Homeless Encampments, Budgeting Best Practices, Public Outreach Practices, and Recruitment/Retention/Succession Planning to name a few. CEAC wishes Rich well in his retirement.





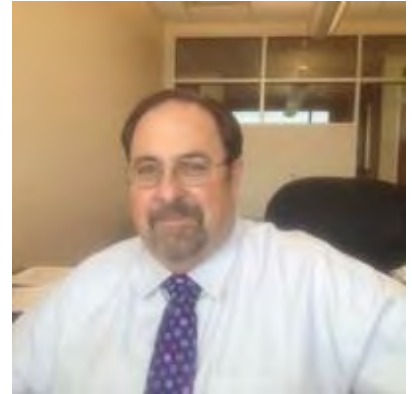
CEAC Welcomes two new Directors

Thomas A. Tidemanson

Los Angeles County

August 23, 1932 - September 18, 2019

CEAC President 1986-87

APWA Top Ten Public Works Leader 1986

Tom was born in Colorado Springs, Colorado, on August 23, 1932 - the oldest of three boys. He attended the University of Colorado where he earned a Bachelor's of Science Degree in Engineering. He joined the ROTC, graduated as a second lieutenant and served ten years in the Army Reserves. Tom would later earn a Masters degree from the University of Southern California.

Tom began his career in 1955 with the County of Los Angeles who recruited him directly out college to begin his career in the Road Department. He was appointed Road Commissioner in 1979 following the retirement of Irv Mohar (CEAC President 1976-77).

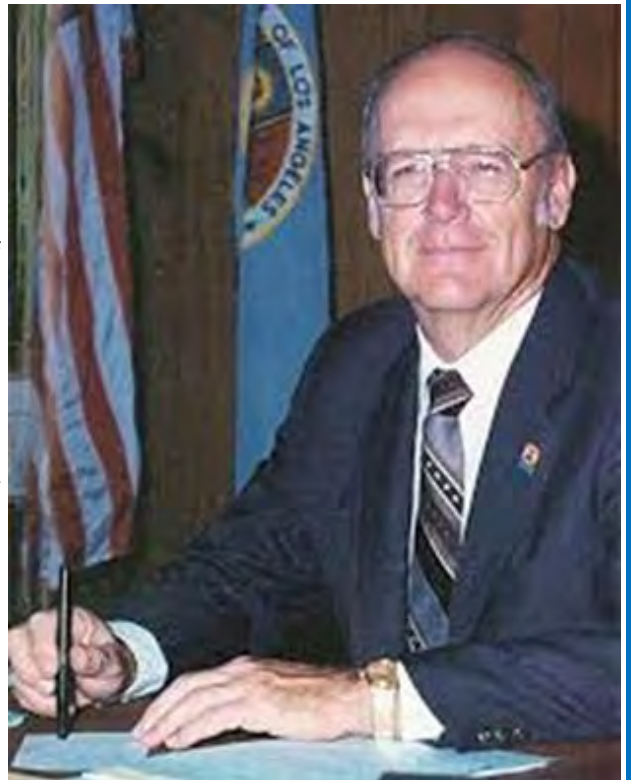
In 1984, under direction of the County Board of Supervisors, Tom helped organize combining the three engineering departments in the County - the County Engineer, the Flood Control District, and the Road Department to form the present Department of Public Works. He was appointed in 1985 to serve as the first Director of the Los Angeles County

Department of Public Works. He oversaw a department at that time of more than 3,800 employees with a budget of \$700 million responsible for roads, sewer systems, waterworks districts, and land development improvements in County unincorporated communities and contract cities and flood control and water conservation in the Flood Control District serving the majority of the County.

Tom retired in 1994 after more than 38 years of County service, the last nine as its first Director of Public Works. Upon his retirement, the Board of Supervisors honored him by naming the Public Works headquarters building - "The Thomas A. Tidemanson Public Works Building".

Tom was actively involved in numerous professional organizations and associations including CEAC, APWA, NACE and ASCE. He served as the CEAC President 1986-87.

Tom will be remembered as a beloved husband, honored father and proud grandfather who made significant contributions to civil engineering and public works, the County of Los Angeles, and his local community.

BUFFALO BULL AWARD

If you read the most recent Droppings which appeared in the July 2019 CEAC Newsletter, you learned about the Buffalo Hide Satchel. The satchel is an important part of our history and the Buffalo Bull Award.

For more information on the very first Buffalo Bull Award, the following appeared in the Spring 2001 Newsletter:

Sometime in late 1971 or early 1972, Irv Mohar, Los Angeles County Road Commissioner, had the bright idea to "plant" some 900 plastic trees and shrubs along a 1.68 mile stretch of Jefferson Boulevard at a cost of \$74,504. Irv's motives were pure noting that the plastic plants required little maintenance and no precious water. Besides, a concrete flood control box conduit beneath the street allowed insufficient soil depth for "real" trees to grow. Well, at least it sounded like a good idea.

As soon as the plastic trees were planted, the calls and letters poured in. The plastic trees were the object of a least one demonstration and numerous acts of vandalism. Los Angeles county Supervisor Kenneth Hahn, the recipient of "hundreds of protests", stated, "Children said the birds would not have a place to nest, the adults said the trees weren't attractive and contributed to smog because they didn't provide oxygen." The County Board of Supervisors subsequently banned the further use of plastic trees. Irv was quoted as saying, "We've found out a number of things so far. One of the things we found is that people just don't like plastic plants."

The CLODS chose to further humiliate Irv with their very first Buffalo Bull Award during the ITTE Spring Meeting held in Santa Cruz in March 1972. In addition to the "cow ship" trophy, the following poem was read to the accompaniment of Fred Metz on the trumpet:

By-Product of Grass Roots Government
Awarded Annually by the CLODS for the
Most Inexplicable
And Incomprehensible Contribution to
County Engineering in California

"TREES"

(of JEFFERSON BOULEVARD)

Written especially for
Mr. Irv Mohar

I hope that I shall never see
another goddam plastic tree!

A tree whose hungry plastic feet
are set in solid green concrete;

A tree that gags on smog all day,
and irks the folks who have to pay.

A tree that will never wear
A nest of robins in her hair;

Upon whose bosom pigeons crap,
to take the place of normal sap;

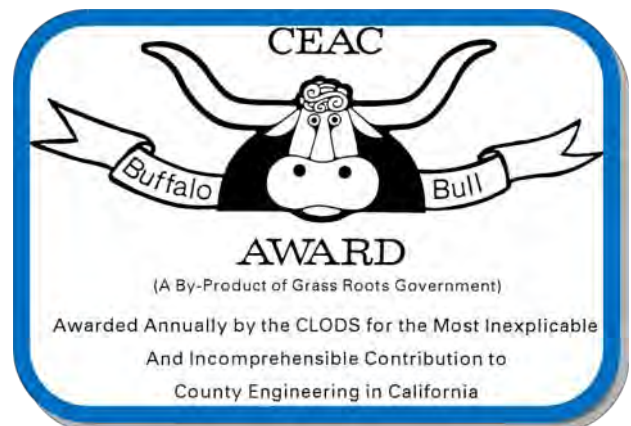
Whose plastic leaves won't synthesize,

1. Call to Order (Porter)

Meeting is called to order at **12:40** p.m. – we have a quorum!

2. Approval of Minutes (Tippett & Kokkas)

September 13, 2018 – Attachment One - Action Item (M-Pack, S DeChellis)

April 5, 2019 – Attachment Two - Action Item

May 23, 2019 – Attachment Three – Action item

For September 2018, Motion to approve Pack, 2nd DeChellis; **Approved**

For April 2019, Motion to approve DeChellis, 2nd Pack; **Approved**

For May 2019, Motion to approve Pack, 2nd Tippett; **Approved**

3. Correspondence (Porter)

Porter; sent a letter to the CLODS inviting them to the fall conference but forgot to ask them to assist with the BBQ, but CLODS graciously volunteered on their own. Also sent letters to NACE president and executive director and invited them to the fall conference.

4. CLODS Report (CLODS)

Gravenkamp ; We had a business meeting and are prepared to have some recommendations in the fall conference for the incoming CEAC Secretary, along with some of the great cooking and equally entertaining program.

5. NACE Report (Machado)

Machado; Our focus has been on the upcoming 2021 NACE conference in California. The NACE 2021 planning committee met several times in a small group; during this conference we solicited more volunteers; we have 28 people who signed up and expect about 10 more potential volunteers; we will request more signups, as we develop the list for the required tasks, and get ready for Alabama in 2020. I will be in Washington DC pushing some federal issues and carrying the NACE resolutions. DeChellis - I have a comment that we should go in force to Alabama since we are hosting the 2021 conference. In addition, Scott McGolpin will be installed as the president of NACE so we should show up to support Scott, just like we did for Phil a few years ago. Porter; I will continue to make that announcement in the fall conference to remind people of the upcoming conferences.

6. CSAC Report (CSAC Staff)

Lee; final stretch of the legislative session, on August 30 both Appropriations Committees will hear hundreds of bills at once — many of those bills will have a quiet death. Major policy focus for CSAC has been on disasters resiliency and funding for homelessness that will flow to all 58 counties with flexibility based on local needs. It was a quite year on transportation policy. , but CSAC successfully protected SB 1 funding from proposals that would've withheld local RMRA funds based on housing production shortfalls. Gerety – We had 120 attending from 34 counties and 11 sponsors; I think everyone enjoyed the engineer's night out. CSAC proposed to hold the 2020 Policy Conference August 19-20, 2020 in Sacramento. Unanimously approved.

7. Regional Directors Reports

S. California – Romo was absent, Fleisch stated that the next meeting is on September 19.

They had several cancelations as it is difficult to find acceptable meeting times due to the size of the region.

Sacramento Mother Lode – Pack; we had our last meeting in May and like to thank Jim Porter for making the trip from San Mateo. Had nine counties present with 18 to 19 people in attendance. The District 3 DLAE from Caltrans, CSAC, and FHWA provided valuable information. Margot Yapp presented the LS&R report and its history. Jim encouraged everyone to attend the NACE conference in Alabama and talked about the 2021 conference in California. Our next meeting is September 18, at 10 a.m. in Sacramento and everyone is invited to attend.

Northern California – DeLeon; since this is my final report as Bob Bronkall is now the new Northern California Regional Director. The bedroll conference on August 1 & 2 was really good and I appreciate all the help from the sponsors. Humboldt brought over salmon for the traditional salmon BBQ. The conference was reduced to two days instead of the typical three, and I thought it worked well as we had good attendance for our region. We had a good regional meeting. Howard Dashiell will be the 2020 Bedroll chair.

Central Coast – No report.

Bay Area – Tackabery; tried a conference call instead of in person meeting in July. It went well; we talked about climate action metrics, the PG&E bankruptcy, Land Surveyor shortage and the public safety power shutdown and how these will affect our continuity of operations plans. Our next meeting is on October 28.

San Joaquin Valley – Balaji; We meet monthly on the third Friday of the month at a different location, it has been an honor to have Doug Wilson attend each meeting.

8. Treasurers Report (Crump)

Crump; referenced the Treasurer Report and answered several minor questions.

9. Committee Reports

Administrative – Pratt was absent. Balbas; in general we have good topics for future discussions; we will keep it 3-4 items initially. Items include looking at different project delivery methods. Orange County leading these efforts.

Oversight – Porter; officers have a monthly conference call to prepare for upcoming conferences.

Fellowship – McNamee, Good attendance and we all had fun.

Flood Control and Water Resources –Leamon; we discussed the upcoming Waters of the State regulations, which the Office of Administrative Law (OAL) is writing, and based on the drafts, we realized the proposed regulations will have an adverse effect in our routine operations. The proposed regulations will classify every roadside shoulder and ditch as “Waters of the State” and we will need a permit to grade shoulders and ditches. Will start engaging Department of Water Resources for modification of the proposed policy to eliminate the unnecessary and restrictive regulations. This is also one of our

legislative priorities and requires board approval to proceed. Motion to approve Machado, 2nd Balaji; **Approved**.

Land Use – Minturn; we talked about disaster recovery as it has many adverse effects on counties. We had 350,000 policies cancelled in the last four years, the only available policies are very costly and are becoming pricier as we have just a few providers in these areas. Fires also damaged the water systems as fumes and melted plastic pipes are part of the recovery effort. The second item was the shortage of land surveyors and what will be the requirements for civil engineers to obtain a surveyor's license. With a lively discussion, the proposed solution should be mutually acceptable to both professions. A subcommittee including engineers, surveyors and dual licensed professionals will explore the potential options; any decision will involve both the Land Use and Survey committees.

Resource Recovery and Waste Management – Goncharoff was absent, however, the committee recommended that the board act on changing legislative priority: "Funding for Resource Recovery Infrastructure" to "Advocate for sustainable and diverse funding streams to develop and manage the infrastructure necessary to manage California's waste and recycling needs". Motion to approve Machado, 2nd DeChellis; **Approved**.

Scholarship – DeLeon; scholarship application period is now open. Solicitations for scholarships applications and request for nominations for the engineer and surveyor of the year awards have been distributed. Engineer and Surveyor of the Year applications are due October 18, 2019.

Surveyor – Jevremovic; the meeting was well attended by over 20 people. We discussed the AG opinion on SB2 regarding the fee collected for Records of Survey and how that is going to affect recording of these documents with the County Recorder, as the opinion is not that clear. We also discussed about a CEAC guide for the preparation of Records of Survey and Corner Records. Since we have been working on it over a year, we decided to get a new prospective and Ian Wilson volunteered to take the lead.

Transportation – DeLeon; reported that the meeting was well attended and great information. We had a presentation by the Department of Finance along with updates from the subcommittees. The FAST ACT reauthorization and our legislative priorities requires a vote by the board to move them forward. Motion to approve Machado, 2nd Tippet; **Approved**
