Meet the 2021-22 CEAC Secretary-Panos Kokkas

"I am happy to be back with the Counties and with all the great people at CEAC. I am also fortunate to be reconsidered for CEAC Secretary and grateful to the CLODS for their faith in me," Panos informed me when asked for an updated bio to re-introduce you to the 2021-22 CEAC Secretary.

Panos Kokkas, the 2021-22 CEAC Secretary, is a results-oriented dynamic professional with extensive technical and management experience in the public and private sectors across the country. He has expertise in the full spectrum of Engineering and Public Works management, including planning, financing, budgeting, project management, engineering, construction, and operations & maintenance activities for municipalities, counties, state agencies, and utility districts. He has been an active member of CEAC for over 12 years and served in many roles.

In his current position, as the Director of the Public Works, County Engineer and Road Commissioner, for Nevada County, he directs and manages all the functions of a full service Public Works department, responsible



for the county's transportation & utility infrastructure system, solid waste services, ten wastewater treatment plants, the countywide fleet services, and transit. He oversees the County's comprehensive operations, and multi -year CIP budgets for road, bridge, utilities, fleet, transit, solid waste, and service district improvements.

Panos began he career in the private sector, where he gained experience in design and construction, from small residential to large commercial and large public works projects.

In the Town of Danville, he managed the approval process of privately funded projects, both residential and commercial. He then moved to Contra Costa Water District, where he worked on unique capital projects. One of the unusual projects resulted in subsequent technical paper he co-authored and was selected as one of the topics to be presented during the tenth earthquake conference in Madrid, Spain. (Bureau, G., & Kokkas, P. "Seismic retrofit of liquid storage tanks." *Earthquake Engineering: Tenth World Conference*, Madrid, Spain, 1992).

As a good husband, he followed his wife when she was transferred to Illinois. At the Illinois State Toll Highway Authority (Tollway), he managed large transportation projects. At the same time, he was an Adjunct Professor of Management at DeVry University in Addison, Illinois, from 1998 to 2005 where he taught Project Management and Principles of Management courses to senior students.

Upon returning to California, he served as the Assistant Director and Director of Public Works at Yolo County, and Director of Public Works for the City of Manteca.

As a young engineer, in 1984, he served the Montana section of the American Society of Civil Engineers (ASCE) as its Chairman of the History & Heritage Committee. He completed the construction history of "The Going-To-The-Sun Road" in Glacier National Park and delivered the keynote address in Glacier National Park during the dedication ceremony, when the Road was designated a National Historic Civil Engineering Landmark on July 27, 1985.

Panos received a Bachelor of Science degree in Civil Engineering from Montana State University, and a Master of Business Administration Degree from Saint Mary's College of California. He is a licensed Professional Engine

Howard Dashiell's professional career has spanned nearly 40 years in both the private and public sectors. He has been the Mendocino County Director of Transportation since 2005, and their County Surveyor since 2010. Prior to joining Mendocino County, he was the Branch/Project Manager for the Lakeport office of the engineering firm Carlile Macy Mitchell & Heryford. He has a bachelor's degree from Cal Poly SLO.

In the Fall of 2019, Howard was introduced as the new Secretary for CEAC. Shortly after the start of 2020, an opening was created as Vice-President of our organization and Howard graciously stepped-up and handled both positions. In 2021, when the normal rotation of officers would have placed him in the Vice-Presidency, the President position was vacated and Howard finished the year performing those duties – including presiding over the first in-person conference in two years in November in Monterey, the CEAC Fall Conference.

For Howard's tireless support and dedication to CEAC, he was awarded CEAC Engineer of the Year for 2021.

NACE UPDATE

As winter is upon us, it is a time to get prepared for the next construction season and to cross our fingers that we do not sustain win-

ter damage to our infrastructure. Key to this infrastructure is federal funding.

ASSO

The recently approved \$1.2 trillion Infrastructure Investment and Jobs Act (IIJA) includes \$550 billion for new programs and \$650 billion for the continuation of core programs, which have

been previously authorized under the Fixing America's Surface Transportation (FAST) Act and other authorizations.

This new transportation bill increases federal-aid formula for core apportioned programs (the funds that are allocated annually to States and MPOs) by about 30% across the board, depending on the individual program. Fund allocations are inclusive of surface transportation block grant program (STBGP) funds, most federal transit administration (FTA) formula funds (5307, 5311, 5339, etc.), and highway safety improvement program (HSIP) funds. Other increases of interest include a 10% increase for congestion mitigation air quality (CMAQ), and a 71% increase for transportation alternatives (TA) type funding (sidewalks, shared use paths, bicycle facilities, etc.).

In addition to funding increases over FY 2021, program funding grows nearly 2-3% per year through FY 2026. That said, direct funding for roadway resurfacing and maintenance is near status quo, with just an inflationary increase.

This new infrastructure bill will focus on climate change mitigation, resilience, equity, and safety for all users, including cyclists and pedestrians.

As infrastructure funding has turned a major corner to support the work we all do, our next advocacy push will include environmental streamlining and FEMA process improvements. This federal advocacy work will take center stage at the upcoming <u>NACO 2022 Legislative Conference</u> in Washington, D.C. from February 12 – 16, 2022.

THE PAINTING

(Editor's Note: The following article was taken from the Spring 2003 CEAC Newsletter to provide history of "The Painting" that you may seen either at the CLODS BBQ at the last month's Fall Conference more about that in this Newsletter—or in the Sept 2021 Issue when Peter Rei was presented "The Painting" by Mike Penrose)

Those of you attending **Mike Sadjadi's** recent retirement (March 2003) once again witnessed the transfer of ownership of **THE PAINTING**. Isn't it amazing how the offer of a simple gift often times becomes an important part of our history? Take for example the Buffalo Bull Aware (it didn't have a name then) presented in 1972 to **Irv Mohar** (LA County Road Commissioner) for "planting" plastic greenery in the median of a major thoroughfare in LA County. Not wanting this trophy to be a permanent fixture in his office, and later his den, Irv chose to share the award with his fellow County Engineers. In my humble opinion, not a one of the subsequent recipients has come anywhere close to matching the plastic tree caper although some have been pretty close.

Immediate Past President and junior CLOD **Tom Hunter** gave *THE PAINTING* to Mike as a part of Mike's retirement celebration. Barbara (Tom Hunter's wife) was so upset at the prospect of loosing *THE PAINTING* she did not attend Mike's retirement.

And, how did Tom come by **THE PAINTING**? Yours truly, as temporary owner of **THE PAINTING** at that time, was asked by Tom during Tom's reign as CEAC President, if I, as CEAC Historian, might research the history of **THE PAINTING**. As Tom had shown such a keen interest in it, it seemed natural that he become the new owner; he was presented **THE PAINTING** at his "debunking" in Pasadena in November 2002 when his reign as CEAC President ended.

And, how did I become its owner? Rather than approach this backwards, let's start at the beginning. When **George Pro-topapas** retired as Director of Public Works for San Luis Obispo County, he received **THE PAINTING** as a retirement "gift" from his Special Districts Administrator in January 1991.

Unfortunately, I don't know the name of the artists but that's probably irrelevant. Similarly, I don't know the cow that produced the Buffalo Bull Award which likewise is probably unimportant. George chose not to display THE PAINTING in his house but instead hung it prominently in his garage. After some time (like one day), Mrs. P (Bev) pronounced "Either IT goes or I'm outta here!!!".



The first CEAC recipients were Verne and Dawn Da-

vis at our annual meeting in 1991 where George, acting on behalf of the CLODS, made the presentation at the Friday breakfast. His presentation was prefaced by noting that Dawn had been heard to say that they needed a picture to hang over their fireplace.

Verne then devised an elaborate scheme to get rid of *THE PAINTING.* Verne's plan took the form of a contest to name the headless engineer with Marlene Demery to act as contest chairperson. The winner was announced at the Friday breakfast at the annual meeting in Palm Springs in 1992. Henry Hirata, San Joaquin County, was judged the winner and offered as a prize, his choice of a weekend for two in Madera or a fifth of cheap whiskey. Henry chose the latter. Second place was awarded to George and I'm sure you can guess his "prize".

Once again, Bev issued her ultimatum and **THE PAINTING** became the proud possession of Henry and Alice Hirata. No doubt George surmised that since Henry had won Verne's contest, he should be awarded the "real prize". Again, the "trophy" was presented at the Friday breakfast during the annual meeting in Long Beach 1994. There was a glitch, however. Henry and Alice had flown to Southern California and there was no way their "prize" which measures 3 1/2-feet by 5 -feet could be taken home. **Richard and Carol Welton**, Fresno County, came to the rescue and offered to transport **THE PAINTING** to Clovis and then on to Stockton, if need be. Henry, in order to prevent a reoccurrence of this embarrassment, devised a way that **THE PAINTING** could be folded to facilitate transport. A secondary benefit of course would be keeping it from public view when folded.

Doug and Linda Wilson, Tulare County, became the next owners when Henry made his presentation at the spring meeting in San Diego 1996. The Wilson's had just purchased a new car with their initial trip to San Diego where it was subsequently stolen. It was indeed fortunate that *THE PAINTING* wasn't in the car at the time. Whether Henry offered *THE PAINTING* to compensate for their loss is unclear.

The Wilson's kept the "prize" longer than most, holding it until the Spring 1999 meeting in Monterey where it was presented during a roast of yours truly. **Mike Walford**, Contra Costa County, was next to own THE PAINTING when it was present as part of his retirement celebration in March 2000. Mike promptly devised a plan whereby he could divest himself of the "prize" one week later at **Art Goulet's** retirement from Ventura County. Unfortunately travel plans kept the Walford's from attending Art's party. Mike entrusted Henry Hirata to make the presentation; however, "the best laid plans...." and **THE PAINTING** greeted Mike and Pam upon their return home.

Mike's next victim was AGAIN yours truly where it was presented in true CLODS fashion at my retirement last August. Having learned the hard way that you can't trust another County Engineer, Mike made the presentation even though it was on Pam's birthday. As Paul Harvey would say, "And, now you know the rest of the story."

Although **THE PAINTING** does not fall under purview of the Tres Pinos Committee, they have strongly suggested that a policy similar to that adopted for the Buffalo Bull Award be put in place. You will recall at the recently concluded Spring Conference, the TPC pronounced there would no three time "winner of the Buffalo Bull Award. A similar policy should be put in place for **THE PAINTING**.

Editor's Note: Since this article was originally written (Spring 2003), *THE PAINTING* has been given to CEAC Past Presidents with two exceptions—Tom Flinn, San Joaquin County, and Mitch Avalon, Contra Costa County—both in 2011. I can only guess that Maurice Shiu got tired of staring at *THE PAINTING* for almost 3 years and decided that he needed to give it to someone. And, Tom Flynn's retirement was just the event!!!

Below is a listing of the past custodians and the current one. The purpose of this list is to allow the CLODS to identify the proper individual to place blame for the loss of this "treasure", because the memory of the CLODS is not always consistent. Preservation of THE *PAINTING is* now **Rick Tippett's** responsibility until he can pass it on .
