#### 3.0 DISCUSSION ITEMS

3.1 <u>APPROVAL OF MINUTES – MARCH 3, 2006</u>

Motion and Second (Crump/Wrysinski) to approve the Minutes of March 3, 2006, CEAC Board of Directors meeting. **Motion was unanimously approved.** 

- 3.2 <u>VISION 2008 STRATEGIC PLAN UPDATE</u>
- 3.2.1 Consider recommendations from the Administration and Member Services Committees regarding the implementation of CEAC Vision 2008 and take appropriate actions.

#### **Vision 2008 Four Key Themes**

- 1. Promote the Public Works profession
- 2. Expand membership participation in CEAC
- 3. Facilitate more interaction with Board of Supervisors

President Shiu referred to his report of June 5, 2006, to the Member Services and Administration Committees, Daniel Woldesenbet and Henry Hash, outlining the fourteen key points that were developed in a brainstorming session held on May 19, 2006. Further, the following seven items were put forth as immediate recommendations.

All agreed to the importance, but still need to figure out how to present our position to Supervisors

Doug Wilson cautioned that we need to be careful about how we get the message out. We don't want to be self-serving and we should send a "good messenger".

- 4. More active at CSAC Policy Committee
- 5. Mini CEAC Conference in August/September to develop CEAC recommendations on Policies in various technical areas and legislative recommendations prior to CSAC Fall Conference
- 6. Continue to work on remaining recommendations

#### Discussion

Doug Wilson emphasized another area of importance, Regions. He noted that the regions are an integral part of CEAC, and the regional aspect would be a good way to get more of the membership involved. It was pointed out that the initial recommendations were developed to provide a structure for immediate actions.

Motion and Second (Crump/Johnson) to accept and begin work on the initial recommendations.

#### Motion was approved.

Doug Wilson cautioned there were too many unclear issues that require clarification.

- 3.3 CSAC REPORT
  - CSAC Legislative Representative DeAnn Baker reported:
- 3.3.1 CSAC is anticipating an on-time state budget and significant legislative progress.
- 3.3.2 Introduction of SB 1694 SAFETEA LU
- 3.3.3 Seeking money in Infrastructure Bond, with \$1 billion for counties and \$1 billion for cities
- 3.3.4 Local road rehab eligible in STIP
- 3.3.5 Prop 1A permanently fixes Prop 42 in November '07
- 3.3.6 Prop 42 early payback in Governor's budget
- 3.3.7 Five different county sales tax measures all failed at recent election
- 3.3.8 Anderson Initiative (eminent domain) main impacts are the protection of private property rights and the affect on redevelopment properties.
  - Both DeAnn Baker and Karen Keene now have full time analysts.

#### 3.4 <u>NEEDS ASSESSMENT REPORT</u>

President Maurice Shiu reported the Bay Area developed a Local Streets and Roads Strategic Plan, which was included for Members review and comment.

CSAC Legislative Representative DeAnn Baker met with RTPA's to explain CEAC's Needs Assessment request. The next meeting will be held on July 19, in San Diego. Brian Lee and Julie Bueren have done a good job of moving this effort forward with assistance from Jim Biery. The RTPA's are generally supportive; we will continue to work with them.

Doug Wilson expressed concern about the consistency or lack thereof in all of our pavement management systems and noted this was the difficult part of past efforts. Maurice Shiu responded that the Committee discussed this obstacle, but felt some common parameters could be developed to gather data for the cities and counties.

#### 3.5 TRAVEL REQUEST FROM BRIAN MCDERMOTT TO REPRESENT CEAC AND PARTICIPATE IN A FOREST RECEIPT TRIP TO WASHINGTON D.C.

Brian McDermott, Siskiyou County, submitted his letter of May 25, 2006, to Maurice Shiu, President, for the members review. Mr. McDermott asks that CEAC provide sponsorship for his travel expenses to Washington D.C. on September 13-14, 2006, to represent Siskiyou and the other thirty-six California counties who stand to lose over \$60 million in funding when PL 106-393 expires at the end of the year. The revenue from this Act provides 50% of Siskiyou's annual road budget and its loss would be devastating.

Motion and Second (Wrysinski/Johnson) to approve sponsorship to Brian McDermott for this important and educational trip. Expenditures are not to exceed \$1,500.00.

#### Motion was unanimously approved.

#### 3.6 OVERSIGHT COMMITTEE

The Oversight Committee submitted draft additions/deletions to the CEAC Bylaws.

The matter was deferred to the Board of Directors September meeting for decision on full membership consideration at the Fall Conference.

#### 3.7 TREASURER'S REPORT

Treasurer Mehdi Sadjadi presented the Treasurer's Report for the period ending May 22, 2006, for member's review.

The Treasurer made the following comments:

One county, Modoc, still has not paid. Mike Crump will discuss with Modoc at the next Regional meeting, scheduled for the week of the 12<sup>th</sup>.

Six (6) new affiliates were added, three from the Spring Conference and three from the NACE

conference. Treasurer Sadjadi advised Affiliate dues, currently \$250.00, could easily be increased if there is a need.

Contracts need to be reviewed with CSAC and MOU's need to be reviewed with the League of California Cities.

Dating back to 1984, the Newsletter Editor is paid a monthly fee of \$350.00, however there is no contract in place, although it is included in the budget.

The Spring Conference generates revenue for CEAC \$15,000 to \$20,000.

The Fall Conference costs CEAC \$5,000 - \$10,000.

#### 3.8 SPRING AND FALL CONFERENCES



### SURVEYOR POLICY COMMITTEE MEETING OF 9/28/2006

The CEAC Survey Policy Committee addresses issues related to the Profession of Land Surveying within County Government. The primary focus is on application of the Professional Land Surveyor's Act (Business and Professions Code Section 8700-8805), the Subdivision Map Act (Government Code Section 66410-66499.58), and the Board of Registration for Professional Engineers and Land Surveyors Board Rules.

Committee membership is comprised of County Surveyors (including those who may carry the title of Director or Deputy Director of Public Works), Deputy County Surveyors, and City Surveyors of large metropolitan cities.

The most important issue recently addressed by the Survey Policy Committee at the CEAC "mini-conference" in September 2006 was related to preservation of survey infrastructure. The Committee recommended that the Board of Directors of CEAC request that CSAC sponsor legislation for monument preservation. If successful, this legislative change will eliminate the antiquated exemption for lots in tracts in collecting the \$10 monument preservation fee attached to grant deeds of property being transferred. Such a change would provide counties and large metropolitan cities with adequate funding to preserve this valuable asset and make future surveys less expensive for landowners, developers, and government agencies.

Currently, the Committee is discussing possible solutions for the shortage of qualified Land Surveyors available to the government for appointment to County Surveyor and other licensed government positions. Many counties have experienced difficulty in recruiting such individuals and, with the low passing rate of those taking the licensing test, the future for filling this vital function may well rest on creative efforts rather than a wide pool of candidates. This topic was thoroughly discussed by the CEAC Oversight Committee white paper entitled "Strategies for Counties to Accomplish Professional Land Surveying Services" which was adopted by the Survey Policy Committee last year.

Other issues being discussed include changes to the Business and Professions Code for preservation of vertical control on Corner Records, supporting efforts to fund the Enforcement Division of the Board of Registration and the Land Surveyor Technical Advisory Committee (LS TAC), and participation in statewide Geographic Information Systems (GIS) committees.

## FLOOD CONTROL & WATER RESOURCES POLICY COMMITTEE MEETING OF 9/28/2006

Underlying and related to a number of legislative agenda desires is something that we are calling the committee's white paper on "Flood Control." It is a proposal for a statewide flood control needs assessment. The assessment would include: a statewide assessment of the potential for damage; existing infrastructure (with condition index); barriers to implementation; and recommendations. After the FCWRPC meeting, a "white paper" subcommittee met to flesh out the issue. It was decided to ask the CEAC Board of Directors for funding that would allow the committee to hire a consultant and scope the problem with a deliverable of an RFP that could be used to hire a consultant to perform the overall assessment. This request was presented to the Board on 9/29/2006. This item has been moved to the highest priority for the committee.

After reviewing FCWRPC existing legislative priorities and guidelines, several additional items were discussed by the committee. Highlights of these action items are as follows:

- 1. Include, as a long term priority item, the clean up of concentrated environmental wastes e.g. Mercury mine sites. The problem being that if you volunteer to clean up such sites, the volunteering party may take on liability for the existing contamination regardless of who may have caused the contamination.
- 2. Use CSAC/CEAC as a forum to sponsor workshops or meetings with appropriate legislative authors on any future "water bond" funding proposals to ensure that flood control needs are considered for funding.
- 3. Support state legislation that provides money for levee rehabilitation/repair/upgrade etc. statewide and not solely in the Bay-Delta area as is currently being proposed.
- 4. An FCWRPC coalition is going to meet with the Department of Water Resources to ask that they either budget \$200 million annually for subvention funding or that they use a budget trailer bill to secure the funding. The coalition will be comprised of representatives from counties currently due subvention funding for past project expenditures including: Orange, Santa Clara, Napa, Los Angeles, Riverside and San Bernardino Counties.
- 5. At the next meeting of the FCWRPC at the Fall Conference, the committee will be discussing the "200-year" flood protection standard currently under consideration by the State and by FEMA.
- 6. Also at the Fall Conference, the FCWRPC will discuss HR4973, which is proposed federal legislation dealing with residual risk and associated costs.

#### LAND USE POLICY COMMITTEE MEETING OF SEPTEMBER 28, 2006

#### **Welcome Remarks and Introductions**

**Agenda Items:** 

#### **2006 CEAC Legislative and Administrative Guidelines**

Discussion was led by Cheryl Creson, Wes Zicker and DeAnn Baker

Items 2, 3, and 4 of the Agenda were discussed together. There was general agreement that there is no legislation to propose at this time from the Land Use Committee, but we should continue to monitor legislation particularly for regional governance issues. Previous legislative proposals have suggested incentives for those entities who participate in smart growth planning such as the "Blueprint" in the Sacramento area. Many rural counties have not initiated such a regional planning process and thus could be at risk for funding opportunities should such proposals not include a rural functional equivalent. In addition, there is concern regarding erosion of land use power for the local City/County governments.

Item 5 on the agenda was regarding Proposition 90 on the November election ballot. Jean Hurst from CSAC discussed this Proposition and the potential disadvantages it would have on public agencies in relation to acquisition of right of way and takings of property, business opportunities, etc. The campaign against it has a number of backers, but additional funding is being sought. Handouts were provided.

Item No. 6 was funding for road maintenance. Wes Zicker discussed two methods that Placer County uses for funding Operation and Maintenance of roads. The first is a County Service Area Zone of Benefit for chip seals and overlays. The second is a Permanent Road Division for "public roads" that aren't County maintained. The County assists the residents in forming a district and assessing themselves for operation and management. The County provides the service and the payment is a line item on the tax bill. Wes is to provide CEAC with the advisory information used by Placer County for these funding options to be posted on the CEAC website.

#### 2006/07 Proposed Action Requests

Fall Conference: A decision was made to invite County planners to our committee meeting at the fall conference in Anaheim. We should also work to schedule a joint meeting with the Planning Directors Association. In addition, it was decided that a list of Best Management Practices should be generated and discussed one at a time at future committee meetings.

#### LAND USE POLICY COMMITTEE MEETING (CONT.)

Potential topics are as follows:

- A. Streamlining Development Processes
- B. Under grounding of Utilities
- C. Development Impact Fees

#### **Adjournment:**

The meeting was adjourned at 11:30 am. The next Land Use Policy Committee meeting will be held from 8:00 am to 10:00 am on November 29, 2006 at the Disneyland Hotel in Anaheim.

#### Ardis Arleen Campbell 1933-2006

"A marvelous person who impacted the lives and captured the friendship of so many people."

Ardis, devoted wife of Honorable CLOD Budge Campbell, mother, and friend, highly respected educator and valued community member, died peacefully, with grace and dignity on Thursday October 12, 2006. She was surrounded and survived by her husband of 51 years, her two daughters Colby and Kenzie of Sacramento and her son Colton with wife Marilyn of Washington D.C. Her oldest son Craigie proceeded her in death.


Ardis was born in Oregon, but spent most of her formative years in Chico. As one might expect, she was "Miss" everything in high school, graduated with high honors from Chico State, with a Bachelor of Arts Degree and secondary teaching credential, and subsequently earned a Master of Arts Degree in counseling from the University of San Francisco. "She was everybody's best friend" according to Budge, who met his future wife in the sixth grade.

Ardis' long career in education began with her first full time teaching position in the English Department at Ukiah High School in 1974, progressed to work as a Dean/Counselor in 1988 and concluded with retirement in 1999. Ukiah High Assistant Principal, Dan Stearns (also one of her former students) said, "She was one of the most popular teachers in the last 40 or 50 years. Ardis made the journey through literature rewarding, fun and enlightening. I couldn't think of a better teacher to have when you're reading 'Romeo and Juliet' as a freshman. You just ended up falling in love with Shakespeare." She loved her "Kids".

Ardis was very active in community affairs and well known for developing the ice cream social in the park, initiating the Bicentennial fire hydrant painting, participating with friends in land-scaping the high school, working with the 4-H, starting libraries for several local elementary schools, substitute teaching, participating in CEAC and on and on.

All of us at CEAC extend our deepest sympathy to Budge and the family.


Jack married the love of his life, June Gundry in 1946 and they celebrated their 60th wedding anniversary in July of this year.



## California condors soar above the Grand Canyon

RAND CANYON, Ariz. — Visitors usually come to the Grand Canyon to look down. Now there's a reason to look up. Dozens of Califormia condors, a species nearly extinct 20 years ago, soar in the wild above northern Arizona.

Many can be seen at the South Rim of Grand Canyon National Park, riding thermals, spiraling higher into the sky.

bird in North America. They stand 4 feet tall and sport a wingspan of more than 9 feet. They are easy to spot: large, jet-black birds with triangular white patches on the bottoms of their wings.

The birds have attracted quite a following. Shelly and Jon Soderberg of Sacramento and their 12-year-

old son had been waiting 90 minutes to see them. Suddenly, two condors began circling above the canyon's Bright Angel Trail, briefly perching on rocks a

few dozen feet from the rim.

Condors are the largest land-based

"It's a bit neater seeing them here than at the zoo," Soderberg said as he zoomed in on them with a digital camera.

Saving the birds has taken decades. Condors, which once lived throughout North America, saw their territory decline over the millennia. But the population plummeted in the past century due to habitat loss, pesticides and hunting (the birds

are scavengers, and those that eat game shot by hunters are poisoned by the lead in the ammunition).

By 1982, the birds were all but gone. Only 22 remained.

"It's about as close to extinct as you can come," said Thom Lord, field manager for the Peregrine Fund, an international bird conservation group.

In a last-ditch effort to save the species, biologists in 1987 removed all of the birds from the wild. Then conservationists began a breeding program at zoos in California and Oregon. Success came quickly.

After five years, the population was back to a few hundred birds.

When it was time to reintroduce them to the wild, some birds were returned to Southern California, but as an experiment, six were brought to northern Arizona, where they had not been seen since 1924.

Most were juveniles that didn't know proper bird behavior. For



example, several roosted near the ground, where they were prey to coyotes. Another drank antifreeze and died.

Now there are about 70 condors in northern Arizona, and up to 20 may be in the Grand Canyon area at any time.


