

William David McIntosh died peacefully surrounded by loved ones on August 11, 2010. Known affectionately as Bill and Mac, he was born to William and Maud McIntosh in Portola, CA, March 24, 1924. “Still waters run deep,” describes Bill. As a father, husband, companion, family man, boss, and friend, he loved unconditionally. He was a good man, honest and loyal, with a dry sense of humor, great warmth, a kind heart and gentle spirit.

After graduating from Lassen Union High School in Susanville, CA, Bill joined the U.S. Navy stationed aboard the USS St. Paul, proudly serving during both WWII and Korea. At the end of WWII he married Dorothy “Dixie” Morgan from Scranton, PA. They settled in Susanville and raised two daughters. Bill began his career as a surveyor with the Lassen County Road Department in 1946. In 1955 he was appointed County Road Commissioner, and in 1960, was named the first Director of Public Works (DPW) for Lassen County. During his distinguished 41-year career, Mr. McIntosh’s work not only drew attention to the needs of small rural counties like Lassen; it demonstrated the unique vision that this high school educated, rural Public Works Director brought to the breadth of state and national public works. He headed development of the County Route Marker Program adopted nationally in 1967. Because of his leadership, Lassen County received the first number, “A-1”, for the Eagle Lake Road, a national award winner for its design and the only County road selected for the 1984 Olympic Torch relay. In 2000, A-1 was officially proclaimed the “William D. McIntosh Highway.”

Bill rose through the ranks of professional organizations to become president of the County Engineers Association of California (CEAC) and the National Association of County Engineers (NACE). Among his many honors, CEAC created the perpetual “William D. McIntosh Lifetime Achievement Award” naming him its first recipient. NACE named him “Rural County Engineer of the Year”. Bill created the CLODS (California’s Loyal Order of Dedicated Servants), the NFL (NACE’s Former Leaders), and the ASOBGHAPES ensuring perpetual connectivity of public works leaders. In addition to the above achievements, Bill also garnered the coveted “Buffalo Bull Award” in 1978.

In 2002, Bill and Dixie moved to the Bay Area to be closer to family. After 58 years of marriage, his beloved Dixie passed away in 2004. Bill’s last residence was in Rossmoor, CA where he built more friendships, enjoyed movies, live music and theater, art class, and excursions to San Francisco and Oakland for cultural and sports events with his dear friend Betty. He remained an avid fan of the San Francisco Giants and 49ers. Bill stayed in daily contact with his many friends around the country through e-mail, luncheons, and visits.

Predeceased by his wife, mother, father and older sister Dorothy “Belle” Ross, Bill is survived by daughters, Lenore (Ron Hunt) and Donna (Mike Melendez); grandchildren Michele, Robbie, David and Elyse; great grandsons Mason and Malik; and sister and nephew Maudie and Brad Walker. He will be greatly missed!

A memorial service will be held at 3 pm Friday, August 27, 2010, St. Bonaventure Catholic Church, 5562 Clayton Road, Concord. A joyous celebration of his life immediately follows at nearby Endeavor Hall, 6006 Center St. in Clayton, CA. Verne Leroy Davis was born February 11, 1925 in Halstead, Kansas, the first of ten children born to Glenn and Dorothy Davis. He and his mother and dad moved to Southern California in 1926 and relocated to Plainsburg, in Merced County, in 1932. Upon graduation from Le Grand High School in 1943, he volunteered and served in the U.S. Navy during WWII from 1943 to 1946 spending most of his military duty in Alaska.

On August 6, 1949, Verne married the love of his life, Dawn Ione Lincoln of Le Grand. She was his devoted wife of over 60 years. When was once asked to comment on his life, Verne said “There are so many wonderful memories, but the very first thing that comes to mind is when Dawn and I were married in Le Grand. It was a beautiful garden wedding in her folks backyard, and everyone was happy.”

Verne began work for Merced County in September 1947. He served the County well for over 38 years. He rose through the ranks and was Merced County’s fourth Road Commissioner and the very first Director of Public Works. He retired April 1, 1985 and was honored by a retirement party at the Merced County Fairgrounds.

Verne was a 53 year member of Merced #83 American Legion, a 50 year member of the Yosemite Masonic Lodge #99, life member of the Merced Historical Society, the first President of the Merced High School Booster Club and a Fresno Tehran Shriner. His hobbies, long ago, included golfing and water skiing (He said he wasn’t very good at either one), but he did play a great game of softball.

On April 17, 2010, just before his passing, he and other Merced County residents over 85 years in age were honored for their longtime contributions to the community.

A friendly, caring individual with a great sense of humor, and whose word was his bond. He will truly be missed by all.

Verne was preceded in death by his parents, Glenn and Dorothy Davis of Planada, two brothers, Don Davis of Saugus and Roy Davis of Merced and a sister Jackie Ralls of Chowchilla.

He is survived by his loving, devoted wife Dawn, son Verne (Sam) Davis II and his wife Debbie of Crows Landing; daughter, Cathy Davis Buljan and John Lupo of Sonora and two beloved granddaughters, Courtney Dawn Buljan of Sonora and Nichole Dyan Davis of San Francisco . He also leaves behind the following brothers and sisters, Joe Davis of Gardnerville, Nevada, Pats Doughty of Merced, Gayle Rowe of Turlock, Sharon Turner of Plumas Lakes, Dorothy Penner and Lyle Davis of Merced; numerous nieces and nephews; aunt, Norma Heft of Idaho and uncles, Less Davis of Venice and Dean McCoy of Sacramento.

David Pierson, 85, of El Centro passed away due to natural causes Saturday, April 17 in his daughter Linda's home in El Centro.

He was born March 31, 1925 in Riverside, CA. He met Ginny on a blind date in Ft. Worth, Texas and the two were married April 22, 1945, six weeks after they met. David was an Army Lieutenant in WWII and was a part of occupying forces in Japan. Following his service in the Army, he attended and graduated from Cal Berkeley. David came to the Imperial Valley in 1953 from the Los Angeles area after he accepted a position with the county. He held various positions, making his way up to Director of Public Works before retiring as the County Road Commissioner.

David was on a number of local, state and national organizations including St. Peter and Paul Episcopal Church board, Rotary Club president, and president of both state and national Civil Engineers Association. After his retirement, David became a member of the national board of AAA Auto Club and did private consulting for the geothermal industry.

David later had a portion of Highway 86 named after him for his extensive lobbying for people in the Imperial County.



In Memoriam

Dee McKenzie

Sacramento County

October 23, 1920 - May 3, 2010



Born in Gerber, CA, on October 23, 1920 to Robert Bertram and Georgianna McKenzie, Dee was a resident of Sacramento County since 1923. Dee passed away peacefully at age 89 at his home in Citrus Heights on May 3, 2010. He is survived by his beloved wife of 66 years, Ruth Mary, and their sons Robert of Sacramento, Gary (Martine) of Santa Barbara, Aaron (Suzie) of Fair Oaks, and David (Diana) of Newman, CA; daughters-in-law Martine, Suzie, and Diana; granddaughters Cristina and Sofia; and grandson Daniel. He was predeceased by his parents and his brother Earl G. McKenzie of Sacramento.

Dee attended Washington Elementary, Sutter Jr. High, and graduated from Sacramento High School in June, 1937. He later received an A.A. degree from Sacramento Jr. College in 1945, and a B.S. in Civil Engineering from Stanford University in 1949 where he earned Magna Cum Laude, Phi Beta Kappa, and Tau Beta Pi awards. He flew B-24's in the 8th Air Force in England during World War II where he earned the Distinguished Flying Cross and five Air Medals as a Captain pilot on a lead crew in the 491st Bomb Group. He also served in the Northeast Air Command in Newfoundland, Canada, during the Korean War.

Prior to WWII, he worked for the Western Railroad, the CA State Controller's Office, and the Army Air Corps at McClellan Field. Following the war he served as a civil engineer for the City of Sacramento, the State Division of Highways (now Caltrans,) and Sacramento County, from which he retired as Director of Public Works in 1986. As Director of Public Works he was the County Engineer, County Surveyor, County Road Commissioner, and Chief Engineer and Administrator for the county's sewer maintenance districts, water districts, storm drainage districts, and the Sacramento Regional Water Quality District.

During his career with the County he played a leading role in the development and construction of many large projects including the Metropolitan Sewage Treatment Plant, the County's Main jail, the original Watt Ave., Sunrise Ave., and Hazel Ave. bridges across the American River, four and six laning of most of the County arterial road systems, and the development and/or extension of new roads including Alta Arden, Madison Ave., and Greenback Lane. He participated in the development of the five lane street (with a turn lane in the middle) and, despite much opposition and difficulty, helped bring this concept to reality in Sacramento County, the state of California, and eventually nationwide. In the refuse collection and disposal business, he brought curbside pick-up, 90 gallon cans, and mechanical pick-up trucks to the County, and he hired the County's first female refuse collector.

He was an active member of the American Society of Civil Engineers, the American Public Works Association, and the County Engineers Association of California. He also served on California's Scenic Highway Committee having been appointed by then Governor Edmond G. Pat Brown. He served 12 years on the Board of Directors of the Sacramento Credit Union, and for over 20 years on the Board of Directors of the Sacramento County Retired Employees Association. He also served several terms on the Board of Trails West, Inc., and he was a long time member of the Oregon California Trails Association.

His honors and awards included the 1963 Engineer of the Year by the Engineering Council of the Sacramento Valley, the Distinguished Service Award from the Sacramento Building Industry Association, and the Silver Bear Award from the Golden Empire Council, Boy Scouts of America. As a father, Dee was always active with his sons in youth activities, coaching, refereeing, adult leadership in the Boy Scouts, Little League, Youth Soccer, YMCA Indian Guides, and the Methodist Youth Fellowship. He and his boys enjoyed frequent camping, backpacking, and mountain climbing adventures together. He taught his sons a love of nature and a deep and abiding sense of personal integrity.

Dee was proud of his sons. He was a devoted husband, and a dedicated public servant. He touched many with his honesty, integrity, and sincerity. He lived to make a positive impact on his world and he achieved that objective in everything he did in life. He will be greatly missed by his family and his many friends.

2. **Approval of Minutes, February 11, 2010** (Woldesenbet) - the minutes were approved. Motion by Julie Bueren, seconded by George Johnson.
3. **Correspondence** (DeChellis) – Four Letters for new affiliate membership was received –1. Safeway Sign Co.; 2. Mark Thomas & Associates; 3. CMP of Sacramento; and 4. Republic Services of Fairfield.
4. **CLODS Report** (CLODS) – Max Bridges reported that there will be a BBQ and entertainment provided at the conference in Riverside.

Early CEAC Newsletters

Our first CEAC Newsletter was published in July 1961 with Bob Glenn, I.T.T.E. as the Editor. Bob also served as CEAC Treasurer. I thought it might be interesting to read some names that appeared in these early editions of the newsletter that may still be familiar to many of you 50 years later. Following are excerpts from some of the early Issues:

Issue No. 1:

Mother Lode Regional Meeting- Road Commissioner Mie Finch and his trusty Assistant, Tom Mlcoch, along with the Yuba County Board of Supervisors, were hosts at Marysville on May 18&19 at a joint meeting of the Road Commissioners and the County Supervisors of the region.

Verne Davis- Following the resignation of Harold Neu, Verne was appointed Road Commissioner for Merced County. While by no means a stranger to many in the Association, we all anticipate with pleasure his active participation in Association affairs.

Future Issues of Newsletter - Decisions on numbers and topics should be made by the Board of Directors. So far, Ye Editor has received no orders or instructions. Possibly the publication should be titled the "If & When Letter".

Contents of Newsletter—Items of state-wide interest shall always be gratefully received at the editor's office. This is your (Association) Letter. (Does this sound familiar?).

Issue No. 2, December 1961-

To the Rescue - Ye Editor is in receipt of a letter written by our faithful Ed Hanna, December 23, from which in part is quoted: "...Now if Santa Claus will bring me a four-in-hand tie....The tie I have has so much gravy spilled on it that the cleaner refuses to work on it any more". Consequently, it is sincerely requested that each of you attending the Conference meeting in Los Angeles bring all of your old ties to the dinner January 24 at the Hollywood-Roosevelt. Member Spotlight

Ruth Caldwell honored with award

One of my perks in writing this column is meeting some remarkable people, and certainly high on that list is 91-year-old Ruth Caldwell. Ruth is sharp and active; living in her own home with her husband, Norm; blessed with pretty good health; and still driving herself to volunteer regularly at the American Red Cross, Santa Barbara County Chapter and to lead a swim exercise class every week at Vista del Monte.

But when you talk to Ruth, you don't get the feeling that any of this is extraordinary for her. After all, she's been faithfully and quietly doing just these sorts of volunteer activities since World War II.

You might even say the Japanese started this volunteer service by Ruth when they attacked Pearl Harbor. She was married on December 6, 1941. Almost immediately, Norm enlisted and became an Air Force officer. (Ruth still quips that they never did have a honeymoon.) The upshot for Ruth was that she became a Red Cross volunteer because, she explains, "during the War it was mandatory for officers' wives to do volunteer work for the Red Cross — mainly rolling up bandages for hospitals."

But even back then, involvement with the Red Cross was nothing new for Ruth. As a school girl, she took Red Cross swimming lessons. In 1932, at the age of 12, she earned certification in the American Red Cross "Life Saving Corps" — and she still has the badge to prove it! What's more, that early exposure to swimming and life saving set Ruth on a life-long path of teaching water safety.

Settling in Santa Barbara a few years after the war, Ruth's husband began working as a civil engineer for the city's Public Works Department, while she worked at Trenwith's Department Store (where Paseo Nuevo is now). But she also volunteered once again for the Red Cross, which in the 1950s was in an old mansion at Chapala and Victoria streets.

Her volunteer focus in those days was swimming and water safety instruction at "the plunge," as she calls it (that is, Los Banos del Mar pool on West Cabrillo Blvd.).

Then over the years, she expanded her volunteer service, teaching swimming at the YMCA, at Santa Barbara City College, to the Girl Scouts and at both Santa Barbara and Dos Pueblos high schools. She even helped develop the swim program at Westmont College, when the school was just establishing itself at its current campus.

She taught swimming, life guard training and water exercise at Westmont for much longer than she realized. "They gave me a service award one time," she says, "and when they added it all up, they said I'd been serving the Westmont swimming program for 30 years."

That wasn't her only service award. In 1985, Ruth received the Red Cross' prestigious Clara Barton Award for meritorious volunteer leadership. According to the award criteria, the recipient "must have enabled the Red Cross to contribute valuable service to the community . . . in cooperation with staff and other volunteers."

In view of this exceptional devotion, including 65 years of service to the Red Cross, Ruth was honored in May with a Lifetime Achievement Award. It was bestowed by the Central Coast Commission for Senior Citizens at the group's annual Older Americans Month celebration luncheon.

As your CEAC representative to NACE, I have the privilege of serving on the NACE Board of Directors and as such, I am required to attend both NACE Board meetings each year. The first Board meeting occurs in conjunction with the annual NACE meeting, which takes place in March/April each year. This year's annual meeting was held in Fort Worth, Texas, where we saw our own Phil Demery installed as the NACE President. The second NACE Board Meeting happens during the annual NACo meeting, held this year in Reno, Nevada on July 17, 2010.

Given our federal transportation legislation, SAFETEA-LU, expired at the end of September 2009 and is being kept alive through continuing resolutions, combined with the urgent need to improve the federal transportation delivery process, NACE President Demery has made it a priority to improve the efficiency of the federal aid program and accelerate the delivery of federal aid projects by local governments. In order to provide FHWA with specific recommendations, President Demery created the NACE Federal Aid Task Group to develop a NACE reauthorization position and propose legislative language. Pat DeChellis was appointed Task Group Chairman, of a select group of county engineers from across the nation. Attached for your review is a copy of the Proposed NACE Legislative Language for Next Transportation Authorization, which was unanimously approved by the NACE Board of Directors.

Also attached is a copy of the NACE 2010-11 Strategic Plan Priorities, which was adopted by the NACE Board. I encourage each of you to read the NACE priorities as they reflect many of the same priorities we have established for CEAC. In addition to the above mentioned transportation reauthorization and federal aid project delivery improvement priority, NACE is emphasizing the need to expand activities with FHWA, improve and expand communications with and between NACE members, increase the number of NACE members active in NACo activities, maintain and grow NACE membership and get more out of NACE partnerships with other organizations. It is very interesting to note the challenges and priorities facing us within CEAC, closely match the national issues outlined by NACE.

NACE News (Cont.)

Realizing the importance of getting more involved with NACE and also the need to show our leadership at the national level, the CEAC Board of Directors voted unanimously to submit a letter of intent to host the 2014 NACE conference in San Jose, California. CEAC will celebrate our 100 year anniversary in 2014 and we invited NACE to celebrate with us by coming to California. CEAC's letter of intent to host the 2014 NACE conference was received by the NACE Board of Directors, along with letters of intent submitted by the Louisiana Parish Engineers and Supervisors Association for Baton Rouge, Louisiana and the Florida Association of County Engineers and Road Superintendants for Daytona Beach, Florida. You can see we have some stiff competition from Florida and Louisiana, so we need your involvement to demonstrate CEAC's strong desire to host NACE 2014. The next step in the decision making process is for each state organization to make a presentation before the NACE Board at the NACE annual meeting to be held in Minneapolis, Minnesota from April 17th to 21st 2011. Based on the presentations, the NACE Board will vote to determine which state will host NACE 2014. I definitely want to win this award on behalf of CEAC, so please share any ideas you have with me, or get involved with developing our first class CEAC presentation. I also encourage you to attend the NACE 2011 conference in Minneapolis to show CEAC's strong support to host NACE 2014.

I want to advise the CEAC membership that the NACE State Directors from the Western Region have elected a new NACE Western Regional Vice President, Ryan Lopossa, from Cowlitz County, Washington, to replace Dale Wegner on his retirement from Coconino County, Arizona. At the announcement of Dale Wegner's retirement, Ryan and I were asked to run for the NACE Western Region VP position. I was honored to be approached by the NACE leadership and to submit my nomination for consideration, but Ryan was elected and I know he will serve our interests well. Please join me in supporting Ryan as he carries out his duties as NACE Western Region Vice President.

Finally, I want to strongly encourage each CEAC Regional Director to nominate a candidate for CEAC/NACE Engineer of the Year and Project/Program Manager of the Year Awards. The CEAC Award winner will be forwarded to NACE for consideration of national recognition. I know we have many worthy CEAC members who deserve to be recognized for outstanding contributions to County Engineering and public service, so please take the time to submit your nominations.

A highlight was a slurry seal demonstration by Petrochem on one of the local Plumas County roads.




