2. Approval of Minutes

Mehdi Madjd-Sadjadi commented that there was no shading of names of those not in attendance and then moved the item. Approval was unanimous.

3. Correspondence (Bueren)

Mehdi Madjd-Sadjadi had two letters to CEAC, one from the family of Bill McIntosh (Lanora and Donna) and one from his sister. Both letters thanking the CLODS and CEAC for their support.

4. CLODS Report (Mehdi Madjd-Sadjadi)

BBQ was successful and well done. The CLODS meeting will be at the next policy committee meeting of CEAC so the pidgeons can participate. The CLODS have offered to assist in any way they can for the spring conference if asked.

5. NACE Report (Johnson)

George Johnson attended the Western Region Conference in Laughlin that was sponsored by the Arizona County Engineers. Mr. Johnson was the only representative from California. He thought it was a very good technical conference and encouraged more attendance from California. NACE western region director was in attendance with about 140 others.

Also mentioned working on the NACE 2014 proposal to bring the annual conference to California to coincide with the 100th anniversary of CEAC. Trip to San Jose is scheduled for site review and promotional preparations for 4/17-4/21 NACE conference in Minneapolis.

A budget from CEAC to assist in the NACE conference effort was requested. At the NACE 2014 committee meeting on November 17, 2010 the amount of \$5,000 was initially discussed, however the consensus of the NACE committee was that \$7.5-\$10,000 should be set aside. George Johnson made a motion to allocate \$10,000 to this effort; it was seconded by Doug Wilson with the modification to have George Johnson approve the expenditures. One of the expenditures will be covering the travel expenses for Merrin Gerety.

6. CSAC Report (DeAnn Baker/Karen Keene)

a) Gas Tax

DeAnn Baker led off the discussion mentioning that the biggest challenge at this time is the 17.3cent new HUTA Proposition 22/26 issue. CSAC counsel does not agree with the LAO position that reverts this fund source back to Proposition 42. Other issues include getting Democratic support in the legislature as the Democrats are not getting the 1 billion general fund relief. There is a need to have the legislature move forward with a 2/3 vote. CSAC is attempting to facilitate this with the current legislature and governor.

Pat DeChellis requested something in writing from counsel as it will be hard to get momentum going to push the 2/3 vote with the LAO opinion.

DeAnn Baker mentioned that transportation stakeholders have requested that CSAC pay \$50-\$100,000 to get a counsel opinion as they are all on the "out" due to supporting prop 22. There is an effort to get the California Chamber (prop 26 sponsor) to write a letter stating that the intent of prop 26 was not to affect the gas tax situation. There is uncertainty on what may be required to get clarity on this item due to lack of support in the legislature.

b) Contract between CEAC and CSAC.

DeAnn Baker recommended an adjustment to this years' contract of \$6,250 to cover actual and expected costs remaining, as well as amending the contract to include an annual minimum increase of 2.5% or CPI, as the CPI has been flat and costs have gone up.

DeAnn Baker brought up the items CSAC has done to minimize costs, including 2 layoffs, elimination of magazine, and holding positions open. Discussed \$2,000 cost of annual report, additional costs for software purchase and training (\$1.5-\$2,000).

George Johnson supported the need for a minimum increase, as CPI was not keeping up with costs.

Mehdi Madjd-Sadjadi stated that the CPI is used by everyone, but it is not working. He brought up that CEAC collects \$131,250 in annual dues (when they are paid) and that CEAC/CSAC staff had to chase down counties this year to get membership fees. Of that, \$6,000 goes to pay NACE dues, so at this time we are spending more than we collect and living on reserves.

Julie Bueren mentioned that we need to look at our revenue sources, however, we get a lot of support from CEAC staff and they are well worth the funds.

George Johnson brought up the savings of \$2,000 could be realized if we did not do the printing of the annual report, just an e-version. DeAnn Baker concurred, stating that with vision 2012 we may have to shift cost allocations to other priority documents.

Mehdi Madjd-Sadjadi credited CEAC staff for all the improvements to the CEAC website. Mentioned though that the CEAC website shows the Office of Treasurer address as CSAC, causing staff work to remail items to him. He felt this could be eliminated and save staff time.

Daniel Woldesenbet motioned to approve the one time fund addition of \$6,250 and the modification of the CEAC/CSAC contract to include a minimum annual increase of 2.5% or CPI, whichever is greater. This motion was seconded by George Johnson and approved unanimously.

DeAnn Baker followed up on the discussion regarding chasing down dues. She, Julie Bueren and Daniel Woldesenbet had met with San Francisco and San Francisco committed to staying involved. They were not in attendance at Riverside, but would attend next year's conference.

Doug Wilson brought up that when he was chair of the oversite committee that they had looked at the CEAC/CSAC relationship and had committed to paying for the additional services CEAC needed from CSAC and thinks we are getting a good deal for our money.

7. Regional Directors Reports

Northern California (Tom Mattson)

No report as there were no meetings since last BOD meeting.

Southern California (Ignacio Ochoa)

Contacted San Diego Public Works, they are scheduling a meeting. He has lost two key positions, looking for a traffic/civil engineer and an assistant director. Julie Bueren brought up that she also has critical openings in her department.

Central Coast (Jim Porter)

No meeting, one is to be scheduled for February.

South Central Coast (Scott McGolpin)

South Central Coast met two weeks ago and Scott McGolpin was elected new regional director, replacing Paul Greenway. Pat DeChellis was able to attend as well. Meeting was at Laguna Seca.

North Bay (Don Ridenhour)

Don Ridenhour, regional director, had to leave early so this report was presented by Susan Klassen. She reported that they had a meeting and had attendance from all counties in their region and is working on setting the next meeting.

Sacramento Mother Lode (Mike Penrose)

Mike Penrose, regional director, had to leave back to Sacramento so this report was presented by Wes Zicker. Wes reported that the region had a meeting.

In closing, Mehdi Madjd-Sadjadi brought up the idea of limiting the number of positions that people hold in the organization so that there are more opportunities for others in the organization to step up.

8. Treasurers Report (Mehdi Madjd-Sadjadi)

Adjustments to the budget will be made per the previous actions to add \$6,250 to the budget for CEAC/CSAC contract and authorize \$10,000 for the NACE effort. Discussion occurred regarding confusion on whether to approve or accept, Doug Wilson stated that accepting is fine.

Pat DeChellis motioned to accept and approve the changes, this was seconded by Daniel Woldesenbet. Motion carried unanimously.

Merrin Gerety brought up that Sonoma County was requesting the consideration of funding to the amount of \$1,500 for the Public Works Secretary Seminar (PWSS)

Mehdi Madjd-Sadjadi brought up that we have a \$10,000 road report study that he has not received a copy of a contract for as well as a flood control item he had not contract for. Julie Bueren volunteered to chase down the road report contract and Karen Keene stated she thought she had sent the flood control contract in. Mehdi Madjd-Sadjadi will investigate his files to see if he can find the flood control contract.

9. Committee Reports

a) Flood Control and Water Resources—(Mitch Avalon)

Mitch Avalon was not in attendance so the update was provided by Karen Keene. Karen thanked the Orange County representatives on the flood control committee for all the effort and work they have been doing providing information on hot topics to the committee. The committee had a good discussion on the Corp of Engineers levee policy. They have been approached by Department of Water Resources to set up a conference call, hopefully to move the needs assessment forward. George Johnson requested a schedule on the needs assessment, Mitch Avalon stated that it is not yet available. San Diego County has filed a test claim against the Regional Water Quality Board.

b) Solid Waste - (Susan Klassen)

There was low attendance at the committee meeting, Susan Klassen will work harder to get the word out. Pat Proano, Los Angeles County, discussed ongoing conversion projects. The representative from Santa Barbara also provided an update on their conversion projects. A roundtable discussion was held on the effects of Proposition 26 on franchise fees and AB 939 fees.

c) Surveyor - (Mike Emmons)

Mike Emmons was not in attendance so the update was provided by Karen Keene. Discussion was held regarding the failure of the survey monument bill. The City of Los Angeles sponsored this bill and will reintroduce. Doug Wilson brought up the surveyor of the year award and how it has been presented. Anomalies have occurred the last two years leading to presentations as if it were a CEAC award, not a committee award. Pat DeChellis will follow up and make sure it is presented correctly next year, things just worked out the way it did due to circumstances beyond control. Doug Wilson reiterated that the CEAC Board of Directors had clearly wanted to stay away from award creep into an "everybody of the year" award.

d) Land Use-(Wes Zicker)

Wes Zicker stated that attendance was low at this meeting. A survey had gone out to all counties regarding items of interest in land use that anyone would like to see. Only 11 responses had come in so Wes asked everyone to please respond, as he needs more counties to weigh in in order to provide relevant discussion items for the committee. Wes stated that the committee was more an informational committee than a legislative committee. Wes said that the committee would like to set up a plan check seminar, discussion centered around not having it at the annual meeting but maybe having a webinar. Wes asked if this needed Board approval. Julie Bueren responded that we could take it up at the BOD. Wes asked if CEAC would sponsor a series starting with a plan check seminar as everyone had supported this approach at the last policy conference. Tom Mattson made a motion to have the land use committee shake out the proposal and come back to the Board if it needed resources to be allocated. Pat DeChellis seconded and the motion carried unanimously.

e) Transportation—(Tom Mattson)

As all attendees of the Board of Directors had attended the transportation committee meeting, no overall summary was provided. Tom Mattson did mention that in his opinion the transportation committee really needed three hours for each meeting, as the two-hour session

did not allow for full discussion of the many issues challenging the field of transportation. Pat DeChellis requested of CSAC staff that a letter be provided by counsel regarding the 2/3 vote issue as related to Propositions 22 and 26 affect on the gas tax. Mr. DeChellis also reminded everyone that he would be sending a letter requesting donations from all the counties in order to continue with an update of the local streets and roads study.

f) Oversight and Special Tasks Committee – (Jim Porter)

As Jim Porter had to leave, this update was provided by Brent Siemer. Brent stated that the oversite committee had approved the new CEAC travel policy update and had prioritized the Vision 2012 tasks. Jim Porter and Brent will work together on the tasks.

10. Other Committee Reports

a) Fellowship (Pattie McNamee)

Patricia McNamee was not in attendance. Mehdi Madjd-Sadjadi brought up that Pattie had been chair of this committee for a long time and maybe it was time to rotate another person into this position, restating his concern that we allow more individuals to participate in CEAC positions. Julie Bueren mentioned that Pattie has been doing an excellent job as head of this committee, and this was a committee that should have an affiliate in charge. General concensus was the leadership of this committee should stay with Pattie.

b) Scholarship (Scott McGolpin)

Scott McGolpin stated that this was a good year for the scholarship program. Two scholarships were allocated to students attending college in Los Angeles County and one in Butte County. There was also a very good response to the Engineer of the year applications.

Pat DeChellis said that having the scholarships awarded by the Public Works Director of the County in which the applicants were attending school worked well and the two Los Angeles county winners were very appreciative of the awards.

11. Life Membership

Doug Wilson nominated Harry Verheul from Kings County for life membership, as he will be retiring soon. While not being active in CEAC lately, Harry has a long history of activity with CEAC in the past and has been very active with the regional CEAC group. Harry has close to 50 years of public service behind him. This motion was seconded by George Johnson and unanimously approved.

12. Unfinished Business

- a) Travel Policy A motion was made by George Johnson and seconded by Pat DeChellis to approve the travel policy changes as recommended by the oversite committee. Mehdi Madjd-Sadjadi abstained from the vote, all others voted in the affirmative to approve the changes.
- **b)** Vision 2012 Brent Siemer discussed the prioritization of the vision 2012 items. The oversite committee will combine priorities 2 and 4 together and priorities 1 and 3 together.
- c) Mission Statement Merrin Gerety brought up a discussion on this item and mentioned that

this is a nice thing to have but not a requirement. Daniel Woldesenbet suggested that the Mission Statement go back through the oversite committee for discussion and recommendation. The Board unanimously agreed that this was the correct pathway.

13. New Business

- a) CEAC Policy Committee Operating Procedures A general discussion was made regarding the number of committee meetings and the conflict with CSAC sessions at the conference. The concepts of shortening certain committee meeting time lengths or eliminating certain committee meetings at this event in order to have time to attend CSAC events was sent back to staff for thought. Merrin Gerety and Kiana Buss agreed to work with Patti Hughes on this issue, as Patti is responsible for scheduling the conference. After review of the proposed adjustments to the written policy committee operating procedures the BOD acted by concensus to add the new language in the Officers Manual and see how they worked.
- **b)** NACE 2014 Budget This item was covered earlier in the meeting and no further discussion or action was needed (see item 5 above, NACE Report).
- c) 2011 Fall Policy Conference Schedule September 8 and 9, 2011 were chosen for the fall policy conference. As the City-County-State-Federal-Cooperative Committee meets on the morning of the September 8, 2011, close coordination between the CCSFC and Policy Conference schedule will need to happen.
- d) Local Streets and Roads After the end of the regular agenda Doug Wilson mentioned that CEAC needs to look at our dues collection rate so that costs associated with our Local Streets and Roads updates could be covered by dues instead of donations. Doug recommended that this be referred to the oversite committee to begin looking at.

This article is a continuation of excerpts from early CEAC Newsletters that began with the 1st issue in July 1961 with Bob Glenn as Editor.

Issue No. 5, January 1963:

Annual Meeting - Disneyland Hotel, Nov. 1962 The proceedings of this meeting , written by Bill McIntosh, Ex-secretary, are herewith attached. Since Ye Editor was not in attendance, no "sidelights" are included herein. However, one most commendable and important action was taken at the business meeting - - the Association voted to pay the membership fee of \$5.00 to NACE for each member county in our Association (Note: This is now \$100).

NACE - At the invitation of your Asociation, the National Association of County Engineers is holding its Third Annual Research Conference in San Francisco in March. This will be the first of such meetings on the West Coast and deserves the support of CEAC participating members. You shall be advised of definite location and dates as soon as decision thereon is made. Bill Jones is chairman of the Local Arrangements Committee. (As you can see, CEAC has long been active in NACE & attempts to bring the 2014 conference to California holds to past form).

Issue No. 6, March 1963:

Third Annual Research Conference - This National Meeting of County Engineers was held in San Francisco, March 7-9 at the invitation of CEAC. Of the total 93 registrants, 47 were from 33 California counties. A total of 19 spouses also attended. Sup-

port by the host state was indeed fine. Representatives were not confined to nearby counties as Hugh Neill (Del Norte), Chuck Shaller (Humbolt), Al Powers (Siskiyou), Dave Pierson (Imperial), Dave Speer, Dave Bird, and Jean Vincenz (San Diego), along with Fred Carnor (Inyo) capably upheld the outlying counties.

Issue No. 9, Jan 1964:

President's Message - On November 9th & 10th, Newt Templin of Los Angeles County, Bruce McClain of Monterey County, our illustrious Treasurer Bob Glenn and myself (Bill McIntosh) met in San Francisco with NACE's Western Regional Subcommittee on Maintenance and made the preliminary steps toward preparing a NACE Maintenance Manual.

Change in CEAC Constitution and By-Laws -While it may be "old hat" to some of our members, it is worthy of mention the the result of the ballot relative to amendment of Article 3, Section 1, increasing CEAC dues to \$50, \$100 and \$200 for small, medium and large populated counties respectively, was better than 16 to 1 in favor of the increase.

Personalities - Ed Hanna, County Surveyor and Road Commissioner since 1946, for San Benito County, resigned as Road Commissioner to accept a position as Field Engineer with J.B.Hanauer and Co. He will continue as County Surveyor on a part-time basis and, temporarily, as a consultant to the County Road Department.

Slide Rules and Surveying by Clay Castleberry

Honorable CLOD and 1973 CEAC President, Clay Castleberry, Butte County, made a presentation on surveying to the CEAC membership in attendance at the Annual Bed Roll Conference last July. Following is a summary of that presentation for all to enjoy.

Recently I was invited to make a presentation on the History of Surveying and Stadia Surveying before a group of California County Engineers. I saw this as an opportunity to display my collection of stadia slide rules and old surveying instruments. I also decided to go back in history and made a replica of a surveying instrument from about 2700 B.C. that might have been used to lay out the Egyptian pyramids, for level courses, right angle corners, and half right angles.

I displayed the following stadia rules (order from top left in Figure 1). (Note that one of the Dempster RotaRules is not shown in the figure, as it is a part of a display of my slide rules at our County Library.)

One can see from the number of makers of these rules that stadia slide rules were a popular specialty model. The K&E Colby Stadia Rule and the Aristo 10065 are not in this collection and surely there are many others. The rules provide the needed accuracy of calculation appropriate for small topographical work and were an improvement over such calculations using 10 and 12 place logarithmic tables and trigonometry functions. Stadia rules are such an improvement that I now wonder why I had to use log tables to solve these problems in surveying class long ago at a university. The Rhodes Arc provided another means of direct reading of horizontal and vertical distances, used principally for taking cross section dimensions in earthwork calculations, but that is another field of study.

I also displayed and discussed my K&E Stadia Hand Transit, N5376S (Figure 2) and as shown in the K&E catalog of 1921 (Figure 3).

Not shown here but displayed at my presentation was my old stadia board and my two Gunter's Chains, one marked "J. C. Chesterman, Sheffield England", thought to be from the very early 1800s. The use of these chains for distance measurement is not required for stadia work. To add to our historical knowledge, I made a replica of an Egyptian surveying instrument (Figure 4), believed to be used circa 2700 B.C. to level the Egyptian pyramid courses and lay out right angles, verticals and half right angles, as degrees had not come into use yet. The device works like this: The horizontal member was calibrated by leveling it with a water tank, whose surface is level with the earth's surface. The plumb bob, pulled by gravity, made a perfect right angle. A mark was made on the horizontal member and when the plumb bob rested there one had a workable level. Making the plumb bob support as a right angle and placing the legs equidistant from the plumb bob marker, one immediately had half right angles. I did not use a water tank to calibrate my replica; I used our kitchen counter which I knew to be level.

Drawings available from the time in Egypt verify the instrument's use. Another verification of authenticity is the use of the same instrument by the actor Charlton Heston in the film, *The Ten Commandments*. This seems to be unique to a time that had not yet recognized degrees of angles.

All in all, my presentation was a great opportunity to illustrate our heritage and to display and share part of my collection of slide rules and surveying instruments.

State Highway – End of an Era

End of the dirt highway

Route 173 considered too dangerous

The last unpaved road in the state highway system closed on Monday.

To a throng of protesters, Caltrans closed the about 5-mile dirt stretch of Highway 173 in Lake Arrowhead due to safety and maintenance concerns.

At least one person has died in the past 10 years after falling down the steep, unguarded mountainside, and Caltrans has spent between \$20,000 and \$40,000 annually to maintain the narrow road on the backside of Lake Arrowhead leading to Hesperia, Caltrans spokeswoman Terri Kasinga said.

"It cuts into our budget to repair the paved roadways up there which need it so badly," Kasinga said.

Escorted by a California Highway Patrol Officer to keep the peace between Caltrans officials and the about 25 protesters, maintenance workers sealed off the road with two K-rails, chains and padlocks.

During the peaceful demonstration, protesters stood before the blockade clutching paper signs reading "Maintain Highway 173 Save lives!"

"It's our only road off the mountain in case of a disaster," said Duane Banner, a Lake Arrowhead resident of 46 years.
