THE POSITION:

The City of Ventura is hiring! We are searching for a Principal Civil Engineer for the VenturaWaterPure Program. This is an unique opportunity to plan, oversee, and implement a potable reuse and ocean outfall project utilizing advanced technologies. Be part of a close-knit team that works hand in hand with operations to successfully deliver Phase 1 of this challenging and forward-thinking program and plan future upgrades that are projected for Phase 2. Come join our team as we align our workforce to better serve our community together — they're counting on us.

We are accepting applications for the position of **Principal Civil Engineer**. The Principal Civil Engineer is part of the City of Ventura's VenturaWaterPure Potable Reuse Program and will be a vital part of the team to ensure program success. This Engineer will work under general direction of the VenturaWaterPure Program Director, performing complex and responsible administrative and technical civil engineering work related to the management and supervision of the design and construction for the VenturaWaterPure Program.

The Principal Civil Engineer will provide project management during the design and construction phases for the projects associated with the VenturaWaterPure Program. Infrastructure projects associated with the first phase of the Program include but are not limited to: an Advanced Water Purification Facility (AWPF) with reverse osmosis, ultra violet disinfection and advanced oxidation processes, groundwater injection and extraction facilities for indirect potable reuse, pipelines and pump stations to support flows between the existing Ventura Water Reclamation Facility (VWRF), along with an ocean outfall for disposal of RO concentrate. The Program will also lead the Wastewater Capital Improvement Project that will replace the current secondary, tertiary, and disinfection processes at the VWRF with a membrane bioreactor and ultraviolet light disinfection.

The Ideal Candidate:

- has a proven track record of project management experience that demonstrates ability to identify and resolve project issues
- has performed advanced technical civil engineering work
- · utilizes a team approach to problem solving
- understands the techniques of managing, scheduling, and monitoring multiple projects simultaneously to ensure timely completion within budget
- demonstrates excellent oral and written communication skills
- experience working with water/wastewater related engineering projects is desirable

This position is designated as "at-will", serving at the pleasure of the appointing authority, and subject to discharge without cause and right of appeal.

VenturaWaterPure

Ventura is one of largest cities in California to rely solely on local water supplies. Rainfall feeds Ventura River, Lake Casitas and groundwater basins to meet all community water needs. But, prolonged drought and regulations have reduced the local water supply. Without additional supply, Ventura's water needs will outpace its supply by 20% as early as 2035.

After a decade of study and analysis, the City is moving forward with the VenturaWaterPure Program. The Program will diversify Ventura's water supply by securing a new, locally owned water source that is not dependent on rainfall to meet future supply needs, meet regulatory requirements, and improve water quality. The VenturaWaterPure Program diverts, treats, and reuses water that is currently discharged into the Santa Clara River Estuary
