Sonoma County experienced 15 FEMA-declared disasters between 2013-2023.

Lessons Learned:

- Rapid response
- Disaster debris management plan
- On-call procurement contracts
- Local government involvement with planning and contracting services is essential

Purpose and Benefits of DDMP

- Establishes clear roles and responsibilities in a debris-generating incident.
- Identifies resources that can be used in response:
 - Debris haulers and monitors
 - Debris management sites (DMS)
 - Equipment
 - Personnel
 - Recycling options, transfer stations, landfill sites

Purpose and Benefits of DDMP (continued)

- Provides debris estimates to aid in planning.
- Identifies priorities and strategies for debris clearing and collection.
- Identifies applicable regulations that must be adhered to in conducting debris operations.
- Provides public information strategies and templates for use in developing public information messages.
- Failure to follow federal guidance and regulations can result in not being reimbursed for expenses.

Pre-positioned Emergency Contracts

 Purpose: To properly procure and preposition disaster debris removal and monitoring contracts that may be activated in any disaster event, to aid in overall recovery and speed of response.

• FEMA eligible



Benefits of Prepositioned Emergency Contracts

- Save time
- Secure outside resources
- Cost savings
- 3-year term

Removal and Disposal Services

- •Debris Removal and Disposal
- Staging / Processing Areas and Services
- Household Hazardous Waste
- •Hazardous Tree and Stump
- Abandoned Vehicle and Vessel

- •White Goods (e.g. appliances)
- •Electronics Removal and Disposal
- •Animal Carcass Removal and Disposal
- Landfill Disposal

Management and Monitoring Services

- •Debris Removal Monitoring
- •Technical Expertise
- •Environmental Health Support
- •Disaster Debris Management
- •Cost Recovery Services for Public and Private Debris Program

Activating Pre-positioned Contracts

•Evaluate the initial scale and type(s) of the services needed;

•Select contractors and facilities able to provide the work needed based on pre-positioned price structures, then-market circumstances;

•lssue task order(s)

•Contracts can be executed with task orders on a departmental level (up to \$500,000)

Board Approved Pre-positioned Contracts in 2023

- 5 Management and Monitoring Services Contracts
