





President's Message

I was fortunate to participate in three regional meetings during the past few months. The Central Coast Regional meeting on January 12 covered a variety of topics from road maintenance to flood control. During the meeting, the members raised concerns regarding the recent systematic push by Caltrans to have local agencies maintain new non-asphalt improvements, (within Caltrans property), by the local agency, by inserting the requirement into the routine "maintenance agreements." In addition to an informative and productive meeting, the excellent culinary skills of the Santa Barbara County crews and the delicious BBQ meats along with the opportunity to see past colleagues and friends made the meeting very enjoyable.

On February 8th, the Sacramento Motherlode Region, voiced the same apprehension during their regional meeting as the Central Coast regarding the recent Caltrans practice to push maintenance of state improvements to local agencies. They noted that the new Caltrans push for "maintenance" is an undesirable development for both cities and counties and will require a coordinated effort by local agencies to oppose and eliminate the practice before it becomes normalized, as outlined in the meeting notes: "Matt Smeltzer was successful in resisting a maintenance agreement during a HWY 49 sidewalk project by quoting from Caltrans own "Complete Streets" manual that the improvements were theirs to "maintain." Blossom Scott-Heim told the team of her Rawhide Bridge project that

has been delayed due to funding and utility relocations, but early on, Caltrans wanted the County to take on all maintenance of everything back of curb including drainage basins, which Blossom has so far resisted. Panos has successfully pushed back on maintenance agreements with Caltrans but recommended that I send an email to him and Josh Pack about our issues and they will take our unified complaint to the TCC and beyond." Concerns with CARB were also topics of discussion, highlighting increased fees and untenable requirements for cities and counties surrounding the electrification of fleet, equipment purchasing and the capacity to complete our work.

Orange County hosted the Southern California Regional meeting on February 29th. Regional Director, Nardy Khan, provided an excellent overview of CEAC including the many ways the organization will enhance the participant's horizon to the profession as well as strengthen our profession for future generations to come. The meeting highlighted several construction projects and a helpful presentation on compost applications, followed by an informative question and answer session that provided informative answers as well as helpful solutions for similar projects.

In the past month, we also had that many director retirements:

- Brian Balbas, CEAC President 2022-23, retired after 35 years with Contra Costa County. We will miss his detailed
 analysis of issues and proactive approach on county matters. We promise not to email him while he is traveling
 and camping enjoying his well-earned retirement. It was great to celebrate his many contributions on March
 1st during his retirement celebration, and welcome his replacement Warren Lai, a long-time county employee
 and active CEAC member.
- 2. **Scott McGolpin**, CEAC President 2013-14 and NACE President 2020, retired on March 14th, after 36 years with Santa Barbara County. We will miss his active participation and detailed knowledge on many subjects including transportation, flood control, and emergency response. Scott promised to attend all golf events for both CEAC and NACE functions, as he needs more practice. We welcome Chris Sneddon a long-time county employee and active CEAC member who was chosen to replace Scott.
- 3. Jeff Pratt, CEAC President 2017-18, retired on March 21st, after 24 years with Ventura County. As CEAC president, Jeff worked on organizational and structural upgrades to improve the CEAC organization. We will miss his knowledge of flood control and emergency management. Fellowship will not be the same as Jeff provided delightful and lively conversation. At this time, a replacement for Jeff has not been named.

We were unable to hold our annual summer Bedroll Conference for the past several years, as a forest fire destroyed of our favorite camp site at Lake Almanor. A new and improved Bedroll Conference will be held on July 24-27, at Camp Tehama, which is about 50 miles east of Red Bluff, off of State Route 36 and 172. A big thank you to both Jessica Pecha from Tehama County and Bob Bronkall from Humboldt County for their diligent efforts to secure the site for this worthwhile event. For those looking for something a little less rustic, the Village at Highlands Ranch has an Inn as well as RV spaces, and across the street is the plusher Highlands Ranch Resort, both about 10 minutes away. This is an excellent opportunity to enjoy the natural beauty of our state, while participating in continuing education through CEAC.

As mentioned in my December message, the strength of the CEAC organization is in the diversity of our members and our unity of purpose. We all have the opportunity to demonstrate both the unity and strength by actively participating in the upcoming meetings. CEAC will host the annual NACE conference on April 15-19, in Palm Springs. This is an excellent opportunity to participate in the various professional workshops that are relevant to our every-day activities. You will be able to see old friends and make new acquaintances that will end in friendships, as well as have an overview of county national concerns and related efforts. 






COUNTY PUBLIC WORKS DIRECTOR CHANGES Around the State....





Brian retired from Contra Costa County in March.





Fifteen County Engineers represented the National Association of County Engineers (NACE) concurrently with the National Association of Counties (NACo) in our nation's capital from February 7-11, 2024. We came together in Washington, D.C. to advocate for what is important to us our association's legislative and policy priorities which often require federal funding, cooperation, and coordination among various agencies. Being physically present in D.C. allowed us to engage directly with the policymakers who control these critical resources. Our group met with staff from the White House, Federal Emergency Management Administration (FEMA) ,and the U.S. Department of Transportation (US DOT).

Our group consisted of **Kevan Stone**, NACE Executive Director; **Jeff Blue** of Illinois, NACE President; **Steve McCall** of Ohio, Vice President; **Jacob Thorius** of Iowa, Secretary; **Chris Champion** of Alabama, Past President; **Rich Sanders** of Minnesota, NACo Rep.; **Pam Dingman** of Nebraska, South Central Region Rep., **Matt Machado** of California, Western Region Rep.; **Josh Harvill** of Alabama, Southeast Region Rep.; **Jeff Linkous** of Ohio, Northeast Region Rep.; **Bart Walls** - Tennessee State Rep.; **Wayne Sandberg** - Minnesota State Rep.; **Joe Tr**ammel—Texas State Rep.; **Luke McGinty** - Alabama State Rep.; **Mike Pniewski**, - Ohio State Rep.; and **myself**, the California State Rep.

At each meeting, the group would go around the room and introduce ourselves and county that we represent. At US DoT, yours truly said Howard Dashiell, Mendocino County, only to have one of the USDoT staff say... "Mendocino County – you just got a \$31.4 million loan from the Build America Bureau for your Railroad"... to which Howard shuddered – not my department... later I discovered that loan was for two small private California Railroads... Sierra Northern (Tuolumne County) and Mendocino's Counties "Skunk Train" which plans to repair the Noyo Canyon Tunnel #1 as well as rehabilitate 27 bridges. The program is called Railroad Rehabilitation and Improvement Financing (RRIF). The only county at this Washington D.C. meeting that got a specific comment/question and Howard biffed it.

Pam Dingman, Jeff Blue, Mike Pniewski, and Matt Machado were our designated speakers at FEMA HQ. Jeff Blue and Rich Sanders were our lead speakers in our meeting with staff at the Eisenhower Executive Building on the White House Campus. (We did not get into the White House.) Later at the NACo Transportation Committee Kevan Stone and Josh Harvill addressed the supervisors and Matt Machado was a panelist.

Louis Tom Mlcoch L.T. Mlcoch, Inc. Honorary CLOD January 21, 2024

As reported by John Presleigh (CEAC President 2016-17)

"A memorial was held on March 16, 2024 for Tom Mlcoch. It was well attended by his family and a large number of close friends including those from his favorite Matson Winery. He died on January 21, 2024. I know that Tom was very proud to be a honorary CLOD. His plaque of being a CLOD was displayed prominently in his house along with a number of other awards.

I saw him at the Winery about two weeks before he passed. Tom loved the outdoors and he was a prolific hunter and could shoot a bow and arrow! He had a shooting range in his back yard! I am surprised he didn't kill one of his neighbors with an errant arrow!"

Tom studied engineering at San-Francisco State University and was also a graduate of the University of California, Berkeley in structural engineering. Tom was a registered engineer both in California (CI0559) and Nevada (010479).

He had more than 45 years' experience in the planning and design of more than 200 bridges of various types (including slab, girder, arch and truss) and materials (including timber, reinforced and prestressed concrete, and structural steel). His responsibilities have included environmental and foundation studies, bridge hydro-logic studies, utilities, preliminary and final design, preparation of contract documents, bid evaluation. con-tract administration, and resident engineering.

Prior to forming L. T. Mlcoch, Inc., he accumulated a broad base of experience in road and bridge design, administration, structures, and utilities. He retired from CH2M Hill after 27 years. Prior to that, he served as a principal in his own engineering firm, as a county engineer and surveyor in Yuba County, road commissioner in Colusa County, and as a bridge engineer for Caltrans and the Division of Bay Toll Crossings.

Tom is a Life Member in the American Society of Civil Engineers having served as President of the Shasta Branch and also an Affiliate Member of the County Engineers Association of California.

The CEAC January 1963 Newsletter identified Tom as the Alternate Regional Director of CEAC's Sacramento Motherlode Region and as a full-fledged member of the Highway Committee (which is now the Transportation Co-Op Committee). The CEAC April 1964 Newsletter gave notice that Tom would be leaving Yuba County and "stepping out of the public trough in hope of finding more and better vitamins elsewhere". At that time he joined John Hamby and Associates in Paradise, California."

Tom was elected as an Honorary CLOD and installed at the CLODS' BBQ in 2013 for his many years of support and assistance to CEAC, to many of the counties, the engineering profession, and the CLODS.






Foothill Basins Maintenance: A rotational sediment removal plan allows for maintenance of critical flood control facilities in canyons within fire hazard zones.

ORANGE COUNTY

Laguna Canyon Channel:

During heavy storms in February 2019, approximately 265 feet of the left side channel wall collapsed, and emergency bracing had to be installed. This project replaces the temporary fix and provides new aesthetic enhancements for the community.

Trabuco Flood Map:

Existing floodplain for Trabuco Canyon; planned improvements will remove the existing box culvert bridge and replace it with a larger bridge to reduce overtopping and increase accessibility for emergency service vehicles and other users.



Santa Ana Gardens Channel Bike Extension:

Project utilizes existing maintenance road to provide 0.75 miles of bikeway connection in economically disadvantaged community.

The improvement also include an upgrade to Friendship Park.

RIVERSIDE COUNTY



(picture above) Beaumont Line 16
Ribbon Cutting Ceremony. Beaumont Line 16 is a flood control storm drain project featuring water conservation elements, and it is a joint project between Riverside County Flood Control & Water Conservation District and Beaumont-Cherry Valley Water District.

The primary objective of this project is to provide flood protection to residents near Grand Avenue in Cherry Valley and increase groundwater recharge within the project vicinity

The original mural was completed on June 17, 1976 by 30 students from Corona High School as part of the Nation's bicentennial celebration. Over the years, the original mural had been damaged and defaced by weather and graffiti. Through the collaborative efforts of the original Corona High students, community members, businesses, sponsors, nonprofits, and local and federal governments, the Prado Dam Bicentennial Mural was restored in 2023.

Project: Dogwood Road Bridge Replacement over Central Main Canal, Bridge No. 58C-0226

Scope:_Replacement of the existing bridge with a new prefabricated steel press-brake formed tub girder bridge with reinforced concrete footing and abutments set on Cast-in-steel-shell piles. It also included installation of sheet piles, AC pavement, class 2 aggregate shoulders, crash cushions, concrete barriers, signage, and striping. Additional work included relocation of existing utilities (i.e. Overhead IID Transmission Line, SoCal Gas underground pipeline, AT&T underground fiber optic line, AT&T overhead communication line, and IID Dogwood Canal facility).

Construction Duration: May 2022 - February 2023. Total Cost of Project: \$6,951,542.34; Funding Source: Measure D-LTA Road Funds (Local Funds)





Project: Clark Road Bridge Emergency Replacement over Central Main Canal, Bridge No. 58C-0227

Status: Construction Complete; Bridge and road open; Final Documents being completed.

Scope:_Replacement of the existing bridge with a new prefabricated steel press-brake formed tub girder bridge with reinforced concrete footing and abutments set on Cast-in-steel-shell piles. It also included installation of sheet piles, AC pavement, class 2 aggregate shoulders, crash cushions, concrete barriers, signage, and striping. Additional work included relocation of existing utilities (i.e. IID Dogwood Canal and Beech Drain).

Construction Duration: May 2023 – January 2024. Total Cost of Project: \$ 5,967,118.41. Funding Source: State Aid Funds SB1-RMRA

Project: Replacement of the Picacho Road Bridge over Yuma Main Canal; County Project No. 6811

Project: Kalin Road Bridge over New River, Emergency Bridge Repair, County Project No. 7122EBR



Scope:_According to Caltrans structure maintenance & investigation record of critical findings report, stream born debris build-up in front of the center bent has led to a large "island" that appears to be pushing storm flows to the south bridge abutment embankment causing the extensive erosion. Due to the extensive erosion, slope stability of the abutment has become critical, that is, further storm flows could lead to slope failure. In the critical finding report, Caltrans recommends two immediate actions:

1) Place scour countermeasures such that further erosion is prevented and

some measure of stability is restored to

the abutment slope.
