

I discovered writing the CEAC submissions for NACE Rural and Suburban Engineer of the Year award that if you are not super active in NACE, there are not enough points in the scoring rubric for a CEAC member to win. With that information in hand the Board discussed last Friday and decided to allow the President to make the call to submit or not submit if the CEAC Engineer of the Year award winner is not active in NACE and missed too many points for participation in NACE. This makes sense as it is the NACE EOY award and they want to recognize their own for active participation in NACE.

One of the treasures of yore, is the gavel that does not come out of the Presidential collection box except once a year. I appreciate that old gavel as it is a relic of a different place and time. It comes from the era of 2-martini lunches, think Mad Men era. I looked for the history of the gavel and have not found anything yet.

It is fun to wield a gavel during official events. It seems to me that the CEAC President should have a gavel that is presentable in public. I have gathered some wood that will be donated for a new gavel to be donated to CEAC. I have some Oak wood out of the 100-year-old oak tree in my backyard that will be turned into a new gavel. That tree has a fun story that is short. I was told by my 93-year-old neighbor Paul, who lived there since 1969 (the year I was

born) the story of my 100-year-old oak tree. Mr. and Mrs. Tilson, of Modesto Lumber fame, built the house I live in. They and their two little girls dug a small hole in the backyard and planted an acorn, then they all spit on the acorn and voila - there is the monster in my backyard that spans my entire yard and is about 10 feet into either neighbors yard on both sides.



One last thing to share. The Snap-E-Tom reception is no more, for now. I know this sounds like Buffalo Bull Award winning, but again times have changed and are continuing to change. In consultations with the CEAC Leadership team, the CEAC Executive Director and CEAC Treasurer, the cost far outweighed the benefits of this reception. The last one was in Palm Springs in 2024. There were more CEAC people there than there were Snappy Tom drinkers from NACE. The hotels have sucked the fun out of the Snap-E-Tom. We are required to buy their booze and have a hotel bartender make the drinks. The cost is now upwards of \$1500, compared to NACE in Orange Beach Alabama which was the last Snap-E-Tom reception that we were allowed to buy the booze, mix the drinks and serve the Bloody Mary's. As an aside, the Snap-E-Tom brand Tomato and Chile Cocktail juice has been unavailable since the mid-2010's as Campbell Soup discontinued the brand.

Compare this to the origin of the Snap-E-Tom as told by CEAC Historian, Dave Gravenkamp (June 2016 CEAC Newsletter):

Did you ever wonder when the Snap-E-Tom Reception started and why it has continued?

I may have already told this story, but if I can't remember, then there is a good chance that you can't either. Like most of my stories about our history, they in large measure come from **The Old Crow**, **Bill McIntosh**. Bill, throughout his career as Lassen County Public Works Director, and probably still today, kept a daily diary. No doubt his diaries have enabled him to accurately "recall" our past.

Bill indicated that the first Snap-E-Tom Reception was the inspiration of **Jack Lambie**, Los Angeles County Engineer, NACE President 1960, and CEAC President 1967. The National Association of Counties (NACo) held their annual conference in San Diego in July 1965. Jack figured it would be a good idea for CEAC to host a reception for the NACE members that were attending the NACo conference. He recruited **The Stud Pelican II**, **Bruce McClain**, Director of Public Works for Monterey County, NACE Western Region Vice-President 1965-66, and CEAC President 1966, and **The Old Crow**, CEAC President 1964 and NACE President 1968, to gather the necessary supplies for the reception. The first Snap-E-Tom Reception was held at the Hotel El Cortez, was well attended and, according to Bill, was "impressive" to the attendees.

The next year, 1966, the NACE Annual Conference was held in Cleveland. Both Bruce and Bill attended and decided to have another reception. Two cases of Snap-E-Tom mix were shipped in by Greyhound bus. As a hospitality suite

wasn't available, the reception was held in their room. Needless to say, it was a bit crowded. NACo met in New Orleans that year, and the Lambie-led clan put on the third California Snap-E-Tom Reception in two years at the Monteleone Hotel.

The following year, 1967, the NACE Annual Conference was held in Seattle. To show a little "class", Bruce and Bill bought three gallon jugs of the cheapest juice you could find, emptied the jugs, filled them with the Snap-E-Tom mixture, set up a table at the entrance to the elevator at the base of the Space Needle, and served Snap-E-Toms to the members as they headed to the top of the Needle. Later the same year, NACo met in Detroit, coincidentally at the same time as the Detroit riots. On the first night of the conference, a 9:00pm curfew was in effect in the City. On the second night, the cur-few was extended to 10:00pm. Despite these obstacles, California managed another reception. Two more receptions were held in 1968, the first in April at the Savory Hotel in Des Moines at the NACE Annual Conference and then in July at the Shoreham Hotel in Washington, D.C., at the NACO Annual Conference. Bill indicated that his suite at the Savory Hotel was so large that it had three room numbers, more than enough room for all of the Snap-E-Tom attendees to fit comfortably.

Starting in 1969, only one Snap-E-Tom Reception was held each year – in conjunction with the NACE Annual Conference. From 1977 through 1983, receptions were held again at the spring NACE Annual Conference and the summer NACo Annual Conference. It was during this period that **Donna Castleberry, Clay's wife** (Clay was CEAC President in 1976) made a beautiful Snap-E-Tom banner for use at the receptions.

During the 70s and early 80s, NACE became more independent and the Spring Conference became the major annual meeting for the organization. The Snap-E-Tom has since been held only at the NACE Annual Conference.

It is quite interesting that CEAC no longer asks to host the Reception; NACE automatically puts it on the program. This important CEAC/NACE tradition has now been going non-stop for forty-four years.

I never ceased to be amazed how pieces of our CEAC history including the Snap-E-Tom Reception, the Buffalo Bull Award, and the CLODS BBQ have carried forward through the years.

(Editor's Note: The Snap-E-Tom Reception has now been going non-stop for 52 years.)

(President's Note: The Snap-E-Tom Reception had a good run and lasted from 1965 through 2024, excepting 2020, due to the COVID-19 pandemic and emergency)

I'm certainly not pleased that the Snap-E-Tom reception was discontinued during my watch, but it had to be done. I too am sad to see the passing of a long cherished CEAC tradition. This is what leaders do, lead, and do what must be done. I'll take my lashings later!

I think this is enough for one newsletter. Know that I love CEAC, all of you, the CLODS, the members and our affiliates and sponsors. You are all what truly makes this organization great, it's the people!

NACE REPORT



Howard Dashiell CEAC Representative to NACE

From February 26th to 27th 2025, the National Association of County Engineers (NACE) concurrently with the National Association of Counties (NACo) were in our nation's capital. We came together in Washington D.C. to advocate for what is important to us - our association's legislative and policy priorities which often require federal funding, cooperation, and coordination among various agencies. Being physically present in D.C. allowed us to engage directly with the policymakers who control these critical resources. Our group met with staff from the White House, Federal Emergency Management Administration (FEMA) and the US Department of Transportation (US DOT).

Matt Machado, Santa Cruz County Deputy County Administrative Officer-Director of Community Development & Infrastructure and currently the NACE Western Region Vice President, prepared the following remarks to be used when addressing County Supervisors at the NACo meeting:

The NACo FEMA Task Force was formed to assist in needed reform. The task force's mission is to foster a strong intergovernmental partnership with our state and federal counterparts, provide tangible federal policy recommendations and emphasize the vital role counties play in the disaster space before Congress and the new administration. We know that without strong collaboration across all levels of government, our communities lack the critical resources and support necessary to protect residents while maintaining essential services. Achieving this requires innovative local approaches and targeted reforms to ensure resources reach impacted communities more equitably and efficiently. Additionally, the task force purpose is: To modernize federal assistance policies and practices, strengthen intergovernmental partnerships, and develop local capacities that improve our nation's disaster mitigation, response, and recovery capabilities.

Our NACo ask:

Streamline FEMA's Public Assistance (PA) Program

FEMA PA represents one of the most critical resources to aid in recovery efforts following a disaster. However, the program is cumbersome, unintuitive and bureaucratically difficult to navigate.

Support any legislation that reduces paperwork and expedites funding for local communities through FEMA PA to ensure recovery efforts happen in an efficient and effective manner.

Create Universal Disaster Application for Disaster Survivors.

Following a disaster, residents face countless applications with duplicative information that leads to poor outcomes for individuals in the most difficult times of their lives.

Support passage of the Disaster Assistance Simplification Act (S.1528 in the 118th Congress) which would create a universal disaster application for disaster survivors.

Ensure Reimbursement for Loan Interest Under FEMA Public Assistance

Following a disaster, many local communities have to take out large loans to assist in the immediate recovery efforts. However, under current law, any interest incurred on these loans is not reimbursable through FEMA Public Assistance.

Support the FEMA Loan Interest Payment Relief Act (S.1180/H.R.2672 in 118th Congress) which would allow for interest on disaster loans to be reimbursed by FEMA.

Lastly, we are focused on getting a seat at the Presidents newly forming committee on FEMA reform. The goal is for this new committee to be set up in 90 days and to have a report in an additional 180 days. We are hopeful that one of our task force members gets a seat at this table. We are drafting a white paper on this now, to convince the white house to include Counties. See attached NACo letter.

This year, one of CEAC's newer members - **Noel Castillo**, San Bernardino County Public Works Director – attended the meetings and said the following: *I wanted to express my gratitude for your leadership and guidance during the trip. I was truly impressed by how concise and effective our messaging was —it was purposeful and impactful. As I continue to get to know the team, I'd love to explore how I can assist in the future. For now, I will continue to champion the eloquent speaking points you all developed. The bullet points were very effective and made a noticeable impact with the administrations staff.*

CEAC is excited to have Noel's involvement – CEAC & NACE need participation to show state and federal leaders we are need reforms in order to accomplish our mission.







BUFFALO BULL AWARD - FUN FACTS

Some "fun" facts about the Buffalo Bull Award:

This is only the second time the Buffalo Bull Award Recipient was from Stanislaus County. The only other time was in 2015, when Matt Machado, Mr. Leamon's predecessor, received the Award.

4 counties have received the Award 4 times:

- 1. Trinity
 - Panos Kokkas 2022 and 2023
 - Rick Tippett 2013
 - Carl Bonomini 2006
- 2. San Mateo
 - Jim Porter 2019
 - Neil Cullen 1999
 - Bob Sans 1993
 - Sid Cantrell 1976
- 3. Contra Costa
 - Mike Carlson 2018
 - Julie Bueren 2012
 - Maurice Shiu 2007
 - Mike Walford 1988
- 4. Los Angeles
 - Pat DeChellis 2008 and 2011
 - Tom Tidemanson 1983
 - Irv Morhar 1972; Irv was the initial recipient he planted plastic trees on Slauson Blvd when real trees kept dying due to vehicle emissions.

Some additional fun facts:

- 1. Anyone else besides Panos and the Newsletter Editor received the Award more than once?
 - Phil Demery received the Award twice but with 2 separate counties (2004 Santa Barbara and 2009 - Sonoma).
 - Tom Hunter (Plumas County) received the Award in consecutive years 1997 and 1998.
 - Jerry Shaul (Lake County) received the Award in 2003 and 2005.
- 2. Anyone besides these recipients hold the Award for more than one year?
 - **Peter Rei** (2001 Recipient) held the Award for 2 years because it was not given in 2002 since CEAC hosted the 2002 NACE Annual Conference and there was no Spring Conference.
 - Jim Porter (2019 Recipient) also held the Award for 2 years because CEAC did not have an in -person Conference in 2020.
- 2. But, **Panos** held the Award for 3 years because it was not given in 2024 since CEAC once again hosted the Annual NACE Conference. Three years is a record that appears to be **UNBREAKABLE**!!!
- 3. Another record that **Panos** holds that will never be matched is that he was nominated 4 consecutive years for the Award, receiving the Award in 2022 and 2023.
- 4. Who held the Award for the shortest time?
 - Tom Mattson—he received the award at the Fall Conference in 2021 because the Spring Conference in 2021 was virtual; Panos received the 2022 Award at the 2022 Spring Conference meaning that Tom held the award for approx. 4 months. Another record that will probably never be matched let alone broken.

DAVID FLEISCH'S RETIREMENT

15 YEARS OF PUBLIC SERVICE

Whereas, Mr. David Fleisch was born in St. Louis, Missouri, and after graduation from continuation high school in San Jose, CA, having left Missouri one step in front of the law and receiving a denial of admittance to the US Naval Academy, he settled for the only school that would take him, California Polytechnic State University, San Luis Obispo. He somehow graduated in 1982, being gifted a Bachelor of Science in Architectural Engineering. During a time of desperately low recruiting numbers, to everyone's astonishment, Mr. Fleisch was commissioned as an Ensign in the US Navy CEC; and

Whereas, Mr. Fleisch needed to buttress his technical skills due to his poor undergraduate performance at a lackluster school, he was sent to UC Berkeley under a special program for mediocre military officers and surprised everyone by earning a Master of Science in Civil Engineering in 1987. He further shocked everyone by graduating from the Naval War College in 1996 with a Master of Arts in National Security and Strategic Studies where the motto is "it's only a lot of work if you do it" – he lived that motto to a "T"; and

Whereas, during his so-so naval career, Mr. Fleisch served in various roles, including Chief Staff Officer, Naval Base Ventura County, Commanding Officer Naval Mobile Construction Battalion FIVE, Chief, Engineering Division, U.S. Pacific Command, and Production Officer for the Navy Public Works Center, San Diego where his success can be mostly attributed to durib luck and some truly amazing subordinates; and

Whereas, Mr. Fleisch was finally flushed out of the Navy as a Captain in 2009 after 28 years of dedicated, but second rate service. Following his disastrous military career, he was desperate for work so began his tenure with one of the few places that hadn't heard about his inferior technical skills, Ventura County, as the Director of Roads & Transportation, later hoodwinking Jeff Pratt to promote him to Assistant Public Works Agency Director in 2021, a job he created, so that he could finally stop pretending to be busy after delegating virtually all his work to the leaders of his three operational departments; and

Whereas, Mr. Fleisch and his wife are residents of the City of Ventura and active in their church and other organizations and we're hopeful that these activities will keep him from doing further damage to the reputation of the County and The Public Works Agency; and

Now, Therefore, Be it Resolved, that the all members of the Public Works Agency expresses their deepest sense of relief and appreciation that Mr. David Fleisch is finally being escorted out of the building after his 43 years of slipshod public service, including his uninspiring contributions to the County of Ventura. The Agency wishes Mr. Fleisch the best in his retirement from the role of Ventura County Assistant Public Works Director and hope that he's able to finally enjoy his afternoon nap without fear of being disturbed by his subordinates conting to ask him technical questions.

Dave and **Joan Araujo**, Director, Central Services Department, Ventura County Public Works

Hello – I'm Joan Araujo, one of the Department Directors here at Public Works.

In life there are people you meet whom you become instant friends and collaborators, and it seems this occurs without any effort. Instantly you know you can trust someone and that you have equal principals, faith, and ethics. For me that happened six years ago, nearly to this day.

I joined Public Works after about 5 rounds of interviews. Oddly, Dave Fleisch was not a part of the selection process. Instead, I met him right after I transferred here. I already knew the majority of Public Works' lead-

ership team through construction projects, LEAP, and recovery teams from Fires. Every two weeks we have All-Directors meetings where we share information, collaborate, report out, make Agency wide decisions, *take instruction well from Dave, even on little things like how to use a mouse*. Immediately after our first meeting Dave popped into my cubicle and gave me a resounding approval. *What a surprise this was*. Working with Dave is working with a force, one not to be questioned, he is a leader through and through.

But actually, there is a secret softer side of Dave. One that welcomes questions. That purposefully reflects on hard messages he has to deliver. He puts great effort into mentoring and guiding staff. He has the unique skill of always seeing the bigger picture and connecting the dots. He is one to apologize if he feels he has said or done something wrong. He is sincere. And just like in his years in the Dirt Navy, he steps up at a moments notice when he is called.

It was January 2021, we were all in the thick of COVID, the vaccine had just been released, the public was angry and did not want to wait. The CEO's office notified our then boss that I was being called up as a Disaster Service Worker to open the County's first vaccine center. Jeff, our Director at the time, Dave and I met. Dave quickly stated this was not a job for one person. The two of us would serve together. We saw the empty building at the fairgrounds on that Friday, met the other DSW's for a brief period. We got the keys to the building at 0800 on Monday, set up, orientated staff on the work flow we created and saw our first patient at 10:00. In fact, that day we saw about 400 patients. Over time we gave almost 2,000 vaccines a day, we delt with power outages, rotating staff, unexpected contract nurses, the rearranging of furniture, the adding of tents, high winds that sailed through the building, news crews, guards that carried a cane and guard that carried guns, we lost our wi-fi, we worked to appease the irate public, and more. We opened the building before the sun rose and we closed it long after the sun set. This was our routine for 6-days a week from January until early June. Dave and I each walked 8-10 miles a day inside of one big Quonset hut. There is no one on earth I would rather have been paired with to tackle the challenge. We often didn't speak for hours, each tackling different issues to keep the vaccine flow moving, but we synchronized like we had long rehearsed the dance. Soon we trained up the other vaccine clinic managers and taught them the methods we used to master the madness. I think it was in this era where he became my work husband, my 'other Dave', and he corrects me just like the one at home does. Crazy huh?!

Together we've welcomed new leaders, shown them the way, and said goodbye to others over the years. Projects have been completed. Dave's leadership has expanded PWA's circle of influence at the regional and state level. There is so very much to be proud of and a huge amount of this is due to Dave's insights, dedication, and ambition.

He has been my friend through the toughest of personal times. I've watched him give to others without hesitation. During this 6-years of working together I saw Dave tirelessly care for his late wife and find his new bride Heidi while he blushed like a young guy telling me all about her.

You've had many chapters to your life, Dave. Childhood, your years at Cal Poly – **Go Mustangs!**, your distinguished career in the Navy and now Public Works for these past 15 years. Next, and not surprisingly you are going into a leadership role of service. They are so fortunate to have you. *You aren't done with me yet though*. I know where you live and how to find you! Besides our spouses serve on a non-profit board together, so I'll be the short one next to you at the next fundraiser.

We will all miss you, Dave. I know I positively will. Thank you for being you. Enjoy Cabo! And when you exit on Friday, Valentine's Day – Kiss – to You!



1. Approval of Minutes The previous meeting minutes were unanimously approved (Motion by Bronkall, 2nd by DeChelis)

2. Correspondence (Leamon) - None.

3. CLODS Report (Sadjadi): Dave Gravenkamp had back surgery and should recover in the coming weeks. Mehdi will schedule the CLODS meeting to align with the Sacramento meeting. CLODS expects to hear from Dave Leamon about the proposed nominees for Secretary. Pat DeChelis suggests the president's message focuses on where we are and what we are doing.

- Sacramento Mother Lode (Randall)—There will be an Online meeting in February. Josh Pack (Butte) will discuss insurance challenges. There will also be a discussion of a regional pavement meeting with CCPIC.
- San Joaquin Valley (Chrun)—Learning roles and responsibilities. Six of the nine counties have committed to next month's meeting. Good information was shared during these meetings, and golf was involved. I promise to plug the CEAC forum at future meetings.
- **Southern California** (Koutroulis)—There have been several changes with Public Works Directors in his region. We are coordinating a meeting for next month. Leamon would like to attend this meeting.

7. Treasurer's Report (Johnson)- discussed final budget. Analysis suggests a 10% shortfall. Recommended a 10% increase for 2025 and 15% in 2026, followed by a 5% increase based on CSAC dues increases. Sadjadi asked about the conference making money. The League of California Cities runs the spring conference, where we make a little money. League sends the itemized list of expenses. Johnson discussed his approach to budgeting conservatively.
